Staff Training and Experience

Intergovernmental Agreement (IA) Exhibit A, Attachment I, III, A, 1, iii.

Professional and non-professional staff are required to have appropriate experience and any necessary training at the time of hiring. Documentation of trainings and licensure shall be contained in the personnel files.

Network Adequacy- IA Exhibit A, Attachment I, II, E, 1, iii, a-d

The contractor shall provide beneficiaries seeking Opioid Treatment Program (OTP) Services with an appointment in three (3) business days. Non-OTP services with an appointment in 10 business days. Contractor shall meet services standards and follow the timely access to care standards for first face-to-face visit, emergencies and afterhours care. The contractor's hours of operation shall be no less that the hours of operation offered to commercial beneficiaries or comparable to Medicaid FFS. Contractors shall have services available 24/7 when medically necessary. The county shall monitor network providers regularly to determine compliance, and take corrective action if there is a failure to comply.
