Further investigation has determined that the release notifications submitted on 11/24/2020 and 12/2/2020 are both attributed to one release, and only one update will be provided going forward. The updated material released quantity estimate is 1,000 barrels of gasoline, of which 318 barrels (as of 12/22/2020) have been recovered. No community impact at this time, other than light/noise associated with cleanup efforts.

As previously reported, the primary cause of the incident is unknown and under investigation. Response to the release is ongoing, and is being supported by several local, state, and federal agencies. Kinder Morgan submits this 30-Day Follow-Up Notification Report Form as an interim report, and will update every 30-Days, or until the investigation has completed. Upon completion of the investigation, Kinder Morgan will prepare a final investigation report and submit in accordance with the Contra Costa County Hazardous Materials Incident Notification Policy.
