- What are the current risks to employees? What are the future risks to employees? These need to be evaluated.
- What are the costs to address liability?
- New and existing chemicals will need to be evaluated.
- What is the best way to communicate the results of the Decision-Making subcommittee?
- It is up to the Departments to decide how to use information and recommendations from the Committee.
- The IPM Coordinator works in an advisory capacity with the Departments.

6. Hear reports from the Decision-Making Subcommittees

Andrew Sutherland reported that the Decision-Making subcommittee is reviewing the ground squirrel decision document and they hope to be done with the review by this December.

7. Hear reports from the Agriculture and Public Works Departments

Larry Yost reported for the Agriculture Department.

- The Department finished their noxious weed treatments for artichoke thistle and purple starthistle in June.
- They are currently working on ground squirrel management along roadsides. They may do work on some Delta Island levees later in the season.

8. Hear report form Larry Yost on the progress toward hiring a new IPM Coordinator

There were 10 applicants that passed the minimum requirements. Eight of these were interviewed. The interview panel chose a top candidate and a backup and made the recommendation to Randy Sawyer, Hazardous Materials Chief Officer. Randy Sawyer and Tanya Drlik will interview both top candidates on Monday and make a final decision.
