Agenda Item IX – DISCUSS Conservatorship Questions:

Email from Cmsr. Geri Stern dated 3/22/23 to Dr. Suzanne Tavano, BHS Director:

Cmsr. Stern to Dr. Tavano:

I did notice on the Org chart that you sent that there is one person, Tyler Sadwith, who is named as the Deputy Director of Behavioral Health for the State. It is not clear from his title or his position on the Org chart what type of oversight his office provides for the totality of Mental Health Services throughout the State, how grants are monitored throughout the 58 counties, and if there is any State oversight of how Grant money is spent. It would be very helpful and informative to know more about that process.

RESPONSE (Dr. Tavano to Cmsr. Stern):

He oversees all M/C (Mgmt./Confidential) SMHS (Specialty Mental Health Services) and SUD (Substance Use Disorder) services for the state.

His office issues BHINs (Behavioral Health Information Notices) which govern SMHS (Specialty Mental Health Services) and SUD (Substance Use Disorder) procedures and practices.

DHCS (Department Health Care Services) conducts Triennial Reviews and Audits of every MHP (Mental Health Professional).

DHCS (Department Health Care Services) requires reporting on timeliness, NACT (Network Adequacy Certification Tool), Grievances, etc.

The EQRO (External Quality Review Organization), contracted by DHCS (Department Health Care Services), conducts annual quality reviews of every MHP (Mental Health Professional) and DMC-ODS (Drug Medi-Cal Organized Delivery System) in the state. Findings are sent to CMS (Community Mental Health Centers).

We submit quarterly financial and outcome reports to DHCS (Department Health Care Services) for state grants. Grants are categorical with distinct goals and outcomes.

You can look at our website to see outcomes of our reviews by the state.

Quality manager reports to the MHC (Mental Health Commission) on the EQRO (External Quality Review Organization), findings.
