For referral regarding 2012 Goal: Monitoring How AB109 Realignment is Affecting Contra Costa County:

- It was clarified that the monitoring would be of mental health consumers who are part of the AB109 realignment process. There were questions as to how it would be determined if they need mental health care, and if they had received care at a lower level, would it be included in the records that were forwarded with them to the County? Would offenders who are considered seriously mentally ill but not violent be included in the AB109?
- Gina said a group she attends in West County addresses ages 18-30 and discusses education, jobs and housing. Brian said it sounds like the West County meeting is about what happens when they're released back out into the community. Brian said he thought we were focusing on in-custody or formally on probation. There was a request for clarification on the definition of non-violent behavior, and who it is who makes the definition. Staff will get actual verbiage to have a correct definition.
- Suggestions given for items to be monitored were:
 - What are the numbers coming into the County?
 - o How has the MHA addressed what they are planning for these people who have serious mental illnesses, so far as treatment is concerned.
 - o What is the fiscal impact on the County?
 - o Is proper care being given to them?
 - o Where people are distributed Cities and their capacity to support and treat them.
 - o How many people being released have serious mental health issues?
