How to Approach

### **Locked Facility Care Made up of 3 parts**

#### **In-patient psychiatric care**

- \$1,500+/day. In 4C, approx.. \$1,250/day covered by Medi-Cal, \$1,150 by Medicare. Max of 47 days stay (5150+5250+5270). Then, approx.. \$400/day Admin. Day rate. 10-11 persons have been in 4C for 100-180 days because no IMD (LPS Conservatorship or State Hospital beds) are available. Result: system "back-up" and greatly increased use of contract (6) and non-contract in-patient psychiatric care.
- Contract In-patient psychiatric care: +\$1,500/day. IMD Exclusion—CCBHS pays "full freight" of daily costs.
- Non-contract in-patient psychiatric care: +\$1,500/day to \$3,200/day—IMD Exclusion—CCBHS pays "full freight" of daily costs.

LPS Conservatorship—Traditional Institute of Mental Diseases (IMD) Facilities. Includes MHRC, SNF, PHF, etc.

- Cost: \$300+ to \$500-\$600/day, depending on level of program/care and type of facility
- Annual Realignment annual cost: approx.. \$5.5M

#### State Hospitals

- 20 beds (14 Napa State, 6 Metropolitan State).—Mainly forensic
- Annual state Realignment annual cost: approx.. \$5.5M

Current Medicaid (Medi-Cal)/Medicare IMD reimbursement exclusion for persons ages 21-64.

Federal HHS—up to 30 day mental health waiver.

National Assn. of Attorney's General (NAAG) signed by 39 state AG's (incl. CA) requesting Congress to repeal the IMD Medicaid (Medi-Cal)/Medicare IMD reimbursement exclusion for persons ages 21-64.
