  - Background: Contra Costa County is anticipating that they will be making at least \$32 million in service cuts across all departments for FY 2008/09. For Mental Health that reduction is approximately \$3.5 million. This is in addition to the approximately \$5 million reduction from the state, making a total reduction of approximately \$8.5 million. Donna Wigand and Dr. Walker will present any available information about:
    - i. How much money the division will have (**in total** from general fund, realignment dollars, etc.) to provide services to all age groups.
    - ii. What programs/services are mandated to be provided (again to all age groups).
    - iii. The impact of the state and local budget reductions on the Contra Costa Regional Medical Center Crisis Stabilization Unit and the Psychiatric In-Patient Unit.

Applications are due by March 28, 2008. Up to \$415,400 is available to grantees for 3 years. The purpose of the Older Adults TCE Grant Program is to help communities provide direct services and build the necessary infrastructure to support expanded services for meeting the diverse mental health needs of older persons. For the purpose of this program, older adults are defined are persons 60 years and older who are at risk for or are experiencing mental health problems.
