 - Background:
 - Current number of filled Commission seats = 12.
 - Meeting Quorum = 7. (Bylaws require 50% plus 1.)
 - Number of votes required for election = 6 (If a "majority of the members present at the meeting" [as it states in #7 in the Bylaws] who vote 'Yes' on an item is less than 50% of the total filled seats on the Commission, then the item fails to pass. For example, if there are 12 filled seats, 7 members must be present to have a quorum. Six or more 'Yes' votes are required for passage of an item.)

6. 5:10 Discussion of Commission's Response to Brown Act Violation(s) [Serial Meetings] as related to election of officers.

DISCUSSION AND POSSIBLE ACTION ITEM.

Background:

- Section 54952.2(b) of the Brown Act states: "Except as authorized pursuant to Section 54953 (which pertains to videoconferencing and teleconferencing of meetings), any use of direct communication, personal intermediaries, or technological devices that is employed by a majority of the members of the legislative body to develop a collective concurrence as to action to be taken on any item by the members of the legislative body is prohibited."
- At the 2007 Annual Training for Advisory Bodies to the Board of Supervisors, Lara DeLaney from the CAO's office and Mary Ann Mason from the County Counsel's office distributed materials that clarified this in these terms (underline and bold are from training materials):

SERIAL MEETINGS PROHIBITED

Advisory body members may only discuss the body's business <u>at a properly noticed meeting which the public can attend.</u>

The Brown Act specifically prohibits face-to-face conversations, phone conversations, or e-mail conversations by a majority of members of the body to develop a concurrence as to action to be taken on an item in the body's jurisdiction. (Gov. Code 54952.2.)

• Examples of Serial Meetings

Commissioner A calls Commissioner B who calls Commissioner C, or

Commissioner A e-mails Commissioners B and C, or Commissioner A has Commission staff talk with Commissioners B and C.

• Developing "Concurrence"

[The] Attorney General has defined "developing a concurrence" broadly. If the discussion is an exchange that helps clarify a member's understanding of a matter or helps facilitate an agreement on a matter or advances the ultimate resolution of the matter, that series of conversations will be viewed as <u>developing a concurrence</u> as to action to

- be taken. Almost any substantive conversation can be viewed as developing a collective concurrence [and is thus prohibited].
- Possible penalties for violation of the Brown Act:
 - According to County Counsel Mary Ann Mason, if the Commission decided not to abide by the Brown Act, the Commission would be vulnerable to legal action. Whatever action they took while in violation of the Brown Act would be voided. They would be given 90 days to re-do the action under compliance of the Brown Act. [This would end up lengthening the time to get the matter done that the Commission violated the Brown Act to do quickly.] Depending on how far the person reporting the violation wanted to take it, there could be a lawsuit and the Commission would be subject to legal fees (which would be recovered from the Mental Health Administration which funds the Commission). The violation would be reported to Health Services Director Dr. William Walker, who would report the violation to members of the Board of Supervisors, who could then forward it to the Internal Operations Committee, which could lead to the removal of Commissioners from the Commission.

 If a member of the public filed a complaint:

 John Public would send a letter of complaint. The D.A. would send a letter to the Commission or individual Mr. Public had complained about, asking for their version. If there was a violation, they would be given an opportunity to cure and correct the problem -- meaning if they had voted on something that was not on the agenda or when they had no quorum, they would have to re-do the vote properly at their next meeting or the action would be negated. The Commission or individual would then be on record with the D.A.'s office as having violated the Brown Act, but if the action was corrected, the D.A.'s office would not proceed. The D.A.'s office can file misdemeanor criminal charges for
