Tom Aswad- Thanked Dr. Moore, Victor, and Fatima for participating in the June 25, 2022, 15<sup>th</sup> Anniversary of S4R. He also thanked Logan and Dylan. S4R and Tom received Congressional recognition for work in the community.

Patricia Rogers- Thanked everyone for attending on July 15, 2022, the Clean Slate Event- It was a success!

Antwon- Shared there was a training on July 23, 2022, for 30 mental health providers in the Contra Costa Coalition. This was held by Rich Minds and GRIP, and it was geared to address Mental Health and Trauma.

# V. <u>BEHAVIORAL HEALTH</u> <u>DIRECTOR UPDATE</u>:

Dr. Suzanne Tavano

Dr. Suzanne Tavano presented the following updates:

As reported by Dr. Steve Hahn Smith in June, Suzanne gave more details pertaining the continuing efforts to implement Electronic Health Records (EHR) for the Drug Medi-Cal Organized Delivery System (DMC-ODS) Alcohol and Other Drugs (AODS) will be joining Streamline along with other 22 other Counties around the State. AODS will be joining this group which will allow for stronger marketing power. With the blessing from DHCS we will be moving from ShareCare to Streamline to make it more of an integrated system. The payment reform is a big change that requires large participation by county departments in order to implement.

Dr. Tavano said CalAIM began in January 2022 and most of the changes were implemented on July 1st, 2022. CalAIM allows for more flexibility, and beneficiaries are eligible to receive services by different providers. Contra Costa has two different Managed Care Plans CCHP and Anthem Blue Cross. In the past, a Medi-Cal recipient could only receive mental health services from one system but now they can receive services from both specialty and non-specialty mental health.

She also stated that prior to the changes, MH providers were reluctant to diagnose substance use disorders due to State audits. Now, they are being encouraged to fully assess all conditions appropriately. CalAIM has facilitated streamlining documentation so that clinicians and counselors are able to spend more time with and serve clients. Likewise, there is recognition for the need to access non- specialty MH services. MHSA funds can now be used for co-occurring disorders.

## VI. AODS Staff Report Program Chief -Fatima Mata Sol

Fatima shared the AODS unit is working on the EQRO Report that is scheduled for September 13-15, 2022. The focus of this review is on quality.

AODS continues to supply the SUD programs and SLE's with Covid Rapid Test Kits.

The Access Line calls are stable, sometimes there are fluctuations on the volume of the calls. Plans to hire 2 new counselors for Access are underway. Guita asked if the calls to the Access Line are placed on hold because there is not enough staff to take the calls. Fatima answered the incoming calls are taken within the parameters or regulatory requirements and presently the volume of calls has decreased.

Fatima added everyone is looking forward to the electronic clinical notes that will go straight into the billing system. Fatima said AODS reapplied for treatment services in the Jail; it is grant funded for the implementation of the Crossroad Program. Access into the jail unfortunately has been restricted due to Covid.

Dr. Moore announced the Executive Committee discussed the newly developed Community Assessment Survey and reviewed the Advisory Board attendance policy.

Tobacco Prevention Project Azi Carter

Azi reported A call to Action Taking place on Big Tabaco on behalf of the Contra Costa Tobacco Coalition on August 16, 2022, at the Concord City Council. Mental Health Commission Dr. Rhiannon Shires

West Contra Costa Unified Schools District, School Based Counseling & Wrap Around Program is available to insured and non-insured school children. The goal of the program is to improve academically while providing emotional & supportive services to the students.
