Azi reviewed Contra Costa County 2021 Tobacco Scorecard as she explained each area of concern regarding tobacco use. Azi emphasized the importance of prevention and its impact in the community. Azi shared information about the ordinance and updates throughout cities in County.

Dr. Shires reported that while attending the Mental Health Commission meeting there was a presentation given by the Center for Recovery & Empowerment (CORE), and the SPIRIT program- which is a 9-unit college course taught in collaboration with Contra Costa Behavioral Health and Contra Costa College. There was application overview present.

Mariella Sanding of the MEDS Coalition gave an update about her outreach to schools and Narcan training efforts. Mariella said that the Fentanyl Fact Sheet for adults is now published. The Youth Fact Sheet is for middle and high school students and currently under development.

Antwon shared that the Contra Costa County Coalition of Health and Wellness contracted with West County Unified School District to provide support to schools and students.
