VI. CONTRA COSTA'S PHARMACEUTICAL DISPOSAL SYSTEM – PANEL PRESENTATION

Michael Kent, gave an overview of the Hazardous Materials Commission. The commission makes recommendations to the Board of Supervisors. The commission effects that examined the unused pharmaceuticals have on the environment when not properly disposed of and discovered that pharmacies were not educating the public about proper disposal of unused prescription drugs. The commission approached the Contra Costa Pharmacy Association regarding educating customers on this issue. During this time, Alameda County approved an ordinance for pharmaceutical disposal. At this point Contra Costa County will wait and monitor Alameda's ordinance to see if any lawsuits or other issue arise. The Hazardous Materials Commission is very interested in continuing to work with the Pharmacy Association on client education and would like to move forward with that issue.

Michael Scahill of the Central Contra Costa Sanitary District, stated that the District established a household hazardous waste collection program fifteen (15) years ago. Approximately four (4) years ago the District has looked into a pharmaceutical disposal program due to the fact that most of the compounds and chemicals that are flushed down the toilet are not removed by the waste water treatment process. The Sanitary District worked with the Sheriff's office and Walnut Creek Police Department to set up a pilot program in February 2009. The program was very successful and now there are eleven (11) collection sites. To date the programs have collected a combined 46,000 pounds of pharmaceuticals. That is then collected by a licensed medical waste hauler, shipped out of stated and incinerated.

Angela Lowrey, Delta Diablo Sanitation District, stated that Delta Diablo also offers free used pharmaceutical drop-off for their customers. Delta Diablo, like Central Sanitation, ships waste out of state for incineration.

Tariq Majid, West County Integrated Waste Management, gave an overview of their collection program.

All three agencies are very interested in the Alameda County ordinance and will be monitoring it very closely to see what issues arise.
