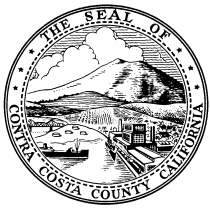

**From East County & Martinez:**

CA-4 W toward Richmond  
Merge onto I-80 W toward San Francisco/Oakland  
Take the San Pablo Ave exit toward Barrett Avenue  
Turn right onto Barrett Avenue  
Turn left onto 22nd Street  
Take the 2nd right onto MacDonald Avenue  
2114 MACDONALD AVENUE is on the left

**From South County & Orinda/Moraga:**

CA-24 W toward Oakland  
Merge onto I-580 W toward San Francisco/Sacramento  
Take the Marina Bay Parkway/S 23rd Street exit, EXIT 10A.  
Turn right onto S 23rd Street  
Turn left onto MacDonald Avenue  
2114 MACDONALD AVENUE is on the left
