#### IV. PUBLIC COMMENT

- Guita Bahramipour commented that during the CCC Inter-jurisdictional Council on Homelessness meetings, members do not have to specify what their vote on an issue is. The members cast their vote by raising their hands. She is wondering if there would be a way to do this with the Advisory Board.
- Antwon Cloird reported that there was a death in the community and Supervisor Gioia submitted a resolution for the family. The gentleman who passed away was a

- youth advocate who will be deeply missed. Antwon also requested a letter from the Board supporting the expungement of his record.
- Tom Aswad reported that he went to the Ujima West Outpatient Program Graduation earlier in the day. Two of the women wrote poems about how their lives have changed. Tom would like to acknowledge Ujima for all of the work they do. He also reported that Support4Recovery (S4R) had a fundraiser the night before at Bridges Restaurant. He thanked the Honorable Judge Clare Maier for her opening remarks, as well as Jaime Rich and Patty Hoyt for their attendance.

#### V. AOD Staff Report

Fatima Matal Sol submitted the Staff report in writing as requested by the Executive Committee. She made herself available for questions. She highlighted the following points:

- The Drug Medical Organized Delivery System's fiscal plan has been approved and Alcohol and Other Drugs Services (AODS) is moving forward with Request for Interest (RFI). The RFI went out to 200+ agencies that spanned Contra Costa County as well as neighboring counties. There will be a bidders conference on March 1<sup>st</sup> at 2425 Bisso Lane and anyone who wants to be a part of the System of Care will be required to attend. Board members are also welcome.
- AODS has been working with the recovery community to develop the Guidelines for Recovery Residences.
- During this week AODS has been going through an annual audit with the Department of Health Care Services (DHCS). We have cleared that majority of the deficiencies from two years ago.
- The Behavioral Health Strategic Plan has finally been completed and was included in the packet for review.

#### X. NEW BUSINESS

Alcohol License Initiatives. Troy's Club 642 First Street, Rodeo, CA 94572

Nabila Sher reported on an environmental scan that she completed at the location of Troy's Club. This location has been in operation for multiple years but it appears that they are applying under new ownership. Nabila reported that The Department of Alcoholic Beverage Control (ABC) allows 5 On Sale licenses and 3 Off Sale licenses within the census track where Troy's club is located. Currently there are 5 On Sale licenses and 5 Off Sale licenses which show that the census track is oversaturated with alcohol licenses. When Nabila visited this location she noticed it was located adjacent to a church and two doors down from a barber shop.

Nabila was able to interview the owner of the Barber Shop who said that Troy's Club has a bad reputation in the community. She added that the owners are good people; however, the patrons have caused issues such as fights in the street after leaving the club. Nabila also reported that in 2012 there was a homicide in front of this location.

Change of Administration name from "Alcohol and Other Drugs Services" to "Substance Use Disorder Services." To reflect the language change within the DSM 5.

Dr. Sutherland opened the floor to discuss changing the name of administration to "Substance Use Disorder Services." The Board entertained a presentation from Zachariah Todd, Access Line Counselor, who explained the changes in the field. Some of his main points were:

- In the Diagnostic Statistical Manual (DSM) 5, which is the standard for diagnosing Mental Health Disorders they changed the language from "Substance Abuse and Dependency" to "Substance Use Disorder."
- The term "abuse" has been shown to be stigmatizing.
- The change to "Substance Use Disorder" within the DSM 5 helps to highlight the fact that addiction is a medical condition.

#### VIII. LIAISON REPORTS

Contra Costa County
Interjurisdictional Council on
Homelessness –Guita Bahramipour

Guita reported that she is learning a lot at these meetings and is really appreciative of that. They just finished the Point in Time survey and she worked with the survey collectors to gather data. She was very interested to know if substance use was one of the reasons why they are homeless. Guita will share the data with the Board as soon as it is made available. Guita is also advocating for an AOD counselor at the CARE centers.

**Tobacco Prevention Coalition**

Mental Health Commission

The Mental Health Commission meeting heard a presentation about the West County Detention Facility that discussed the planned addition of mental health and AOD services. The Commission is in support of the addition.

Antwon Cloird reported that he attended the CPAW meeting in which they discussed funding opportunities in the city of Richmond. It is his understanding that the only program being funded in Richmond is RYSE for \$483,000.
