- Antwon Cloird reported that he worked with the Sim's family, who lost a family member at the Capri Club in El Sobrante, earlier in the day. Antwon would like direction from Fatima about how to inspect this location. Antwon also reported that he worked with a community member in need of detox. The location nearest to him asked for 80% of his income. Antwon believes this is unrealistic because this community member would be unable to pay his rent if 80% of his income was required for detox.
- Tom Aswad stated that on May 27th

S4R is inviting alumni from all treatment programs because S4R wants to learn what is and what is not working for them with their alumni associations. The event will be held from 5:00pm – 9:00pm at the New Life Church.

 Doug Sibley encouraged guests to apply for positions on the Alcohol and Other Drugs Advisory Board because of multiple vacancies in their district.

V. 3rd Annual Sobriety Walk on July 15th

The Board entertained a presentation from Mike Raccoon Eyes Kinney and some of his affiliates from the city of Richmond. Some of the main points of the presentation were:

- There are approximately 25,000 people identifying as Native American between Crockett and Richmond.
- There is a proliferation of liquor stores in Richmond and San Pablo. Those two cities combined have 25% of the county's liquor stores while only having less than 14% of the county's population.
- Approximately 30% of schools and parks in West County are within 1,000 feet of two or more liquor stores.
- Within the Native American Culture there is a historical affinity of walking. So they are hosting the "3rd Annual Sobriety Walk" on July 15th to promote and publicize the issues that affect the Native American community. They asked that the Board join as partners in this event, attend and help with promotion.
- The services provided at the Native American Health center in Richmond are for everyone.
- They also asked if the Board could look into a retail establishment entitled *Uncle Sam's* in Richmond. It is located across the street from a newly renovated park. There is an excess amount of drinking at the park and it is believed that the alcohol is supplied by *Uncle Sam's*. They asked if the Board could develop guidelines on issuing liquor outlet permits to prevent locations like this in the future.

VI. AOD Staff Report

Fatima Matal Sol submitted the Staff report in writing as requested by the Executive Committee. She made herself available for questions. She highlighted the following points:

- Alcohol and Other Drugs Services (AODS)

 contracts until December because of delays
 at the federal level with the Drug Medi-Cal
 contract. There are 16 counties opting in to
 the Waiver and 3 counties that are currently
 operating under the Waiver.
- In Contra Costa County there are contracts with 2 youth residential Treatment facilities: Thunder Road in Alameda and R'House in Santa Rosa. Unfortunately R'House announced that they are closing and Thunder Road is not operating at capacity. AODS plans to release a Request for Proposals (RFP) for youth Treatment facilities.
- The Board of Supervisors entertained presentations on the proposed Departmental Budgets on April 18th and Fatima passed around copies of the Health Services Budget for all Board members.

VII. COMMITTEE HIGHLIGHTS Executive Committee

The Executive Committee discussed the Senate Bills that appear under New Business on the agenda. They also prepared 2 letters for Cynthia Belon, Behavioral Health Director, one in support of the Recovery Residents Guidelines and one in opposition of an Administrative name change.

She gave a report about the Recovery Residence Guidelines and stated that she would like to see full integration of Mental Health and Alcohol and Other Drugs Services. Anne Sutherland M.D. believes that Substance Use Disorder clients are marginalized and underserved and could use more programs throughout the county. She encouraged Board members to attend the next Mental Health Commission meeting scheduled for May 3rd during which they will have a public hearing for the 3 year MHSA Strategic Plan.
