- Guita Bahramipour thanked Jill Ray and Dominic Alliano for attending the Advisory Board meeting on behalf of their supervisors.
- Dominic Alliano updated the Board on the Concord City Council's approval to deliver of medical marijuana within the city and a temporary ban on marijuana businesses while they wait for more direction from the state. Ginger Edwards attended the meeting and spoke on behalf of Support 4 Recovery (S4R) in favor.
- Jill Ray thanked Tom Aswad for starting the discussion on the need for transitional housing. Since the last Board meeting there was a meeting between Lavonna Martin of Health, Housing and Homeless (H3) and Cynthia Belon, Director of Behavioral Health to discuss transitional housing needs in Contra Costa. There are funds from the state specifically for Transitional Housing and the requirements to receive the funds are changing so Contra Costa will soon be applying for them. Also, Contra Costa has received a technical assistance grant from No Place like Home which will go towards conducting a needs assessment for housing across the system.
- Antwon Cloird reminded everyone of HUD's program to assist nonprofits in applying for and receiving housing vouchers.
- Tom Aswad thanked Jill Ray for her report and for setting up the meeting between Lavonna and Cynthia Belon. Tom also thanked Fatima for providing a Spanish speaking staff member at Pueblos Del Sol to conduct Medi-Cal enrollment. Tom also announced that S4R is celebrating its 10 year anniversary this month.
- Antwon reported that August 27th there is a Soulful Softball Sunday that is in remembrance of Landrin Kelly who had the TK foundation. Also, on July 15th Men and women of Purpose are doing their annual BBQ at Nicholl Park in Richmond. Antwon invited the Board to attend this event.

- The proposed hours of service will be from 11:00am – 10:00pm Sunday – Thursday and 11:00am – 2:00am Friday – Saturday.
- There is no school close enough to this location that the license would be in violation of the Deemed Approved Ordinance.
- Adjacent to this location is a fire station.
 Nabila interviewed the fire captain who said that having the Moose Lodge there would probably be quieter than the kids who use to occupy the Boys and Girls Club at that same location.
- Nabila interviewed a sheriff's deputy who stated that this location is an area of moderate crime. The biggest concern the deputy had is the homeless population attracted by the creek located behind the location.
- The El Sobrante MAC submitted a letter in favor of issuance of the license. The MAC letter was available for review.

Fatima Matal Sol gave a presentation on the Drug Medi-Cal Organized Deliver System (DMC ODS). The following highlights were provided:

- Contra Costa County is now the 5th County to have an approved DMC ODS plan.
- The plan will go into effect on July 5th when all providers will transfer their waitlists to the Behavioral Health Access Line.
- Effective July 5th beneficiaries will call the Behavioral Health Access Line for a screening and level of care determination and referral to treatment.
- It is now a requirement that we can no longer have a waitlist.
- Each provider is required to have a Medical Director for consultation but they do not have to be on site at the provider's location.
- Providers now have to be Drug Medi-Cal Certified in order to hold a contract with Alcohol and Other Drugs Services (AODS).
- AODS is focusing on co location of Substance Abuse Counselor in Mental Health Clinics and in Homeless Shelters staying true to the Behavioral Health's goal of "No Wrong Door."
