AB 109 Community Advisory Board (CAB) Presentation.

Talia Yaffa Rubin, LCSW and Angelene Musawwir, LCSW gave a presentation regarding the "AB 109 Community Advisory Board (CAB)." Some of the main points from this presentation are as follows:

- Assembly Bill 109 (AB 109) passed in 2011 and transferred the responsibility for 40,000 California state prisoners from state supervision to county supervision.
- AB 109's intent is to provide counties with incentives to reduce the number of people being sent to state prisons.
- The Community Advisory Board is a 12 member board and each member is appointed for a three year maximum term.
- The CAB's role is to make recommendations to the Community Corrections Partnership (CCP) which is comprised of Probation, Health Services, Public Defender, Sheriff's Department, etc. The CCP then develops policy and budget recommendations to the Public Protections Committee (PPC) who then brings recommendations to the Board of Supervisors.
- The legislation asserts the importance of adopting a "Justice Reinvestment"

which is a data-driven approach that seeks to cut spending and reinvest savings in practices that have been empirically shown to improve safety and hold offenders accountable.

- The goals of the CAB are to:
  - Address the big picture by advancing the county's consideration of the role, scope and impact of the criminal justice system on the community.
  - Advance justice reinvestment by ensuring Contra Costa is working to reinvest its criminal justice resources to support community/corrections programs.
  - Provide policy and budget advocacy.
  - Serve as a watchdog to protect and safeguard AB 109 revenues and investments.
  - Gather and provide information and communication to build a stronger relationship with the community to educate them on what's happening with AB 109 and to receive input.

#### IV. PUBLIC COMMENT

• Tom Aswad reported that Support4Recovery (S4R) has hosted multiple activities to celebrate September as National Recovery Month. S4R hosted its first Wellness4Recovery Fair in partnership with John Muir Behavioral Health and it was well attended. Wheels4Recvoery, originally scheduled in September, was postponed to October 15<sup>th</sup>. On September 19<sup>th</sup> S4R attended the Contra Costa County Board of Supervisors meeting to receive a proclamation and Tom thanked Rita and Ujima for bringing women in recovery to the meeting.

#### VI. AOD Staff Report

Fatima Matal Sol submitted the Alcohol and Other Drugs Services (AODS) Staff Report in writing prior to the meeting and made herself available for questions. The following are key points from the discussion:

- During the week of September 18 22 the Access Line received 373 calls. During the same timeframe there were 65 screenings and referrals conducted. AODS staff are currently reviewing the data to see what we can learn from it.
- The Access Line now has four (4) full time Substance Abuse Counselors which has eliminated the need for call backs.
- There has been an increase in calls for the Choosing Change program because of a rise in addiction to heroin.
- AODS has made tremendous progress with the courts and judges who are no longer requiring people to attend 300 days of residential treatment. Instead clients are mandated to AOD treatment.
- Incarcerated clients are now able to call the Access Line to speak for 12 minutes. Of the

four (4) Access Line staff there is one (1) staff member assigned to detention, so when an incarcerated client calls they will be able to receive services immediately.

Contra Costa County Interjurisdictional Council on Homelessness –Guita Bahramipour Guita Bahramipour reported that she continues to be impressed with all the services that are being offered as it pertains to combating homelessness.

**Tobacco Prevention Coalition** 

Anne Sutherland M.D. reported that there are three main highlights from the last Tobacco Prevention Coalition meeting:

- Oakland and Palo Alto passed regulations to limit flavor and menthol tobacco products within 1,000ft of schools, parks, playgrounds and libraries.
- The coalition has identified five (5) at risk cities where they will focus their efforts: Antioch, Martinez, Oakley, Pittsburg and Walnut Creek.
- The coalition is also working on banning smoking at the Contra Costa County fairgrounds.

Mental Health Commission

Sam Yoshioka reported that the Mental Health Commission hosted their retreat the previous weekend. Sam reported that the majority of the Boards and Commissions across California have merged to be a "Behavioral Health Commission" no longer having a separate Mental Health Commission and Alcohol and Other Drugs Advisory Board. Sam also shared with the Board, the Behavioral Health Boards and Commissions 2017 Data Notebook that focused on the aging adult population.

Consolidated Planning Advisory Workgroup (CPAW)

Fatima Matal Sol reported that she attended the September CPAW meeting and gave a presentation related to the Drug Medi-Cal Waiver.
