 Antwon Cloird shared that Susan Cinelli was a strong advocate for Substance Use Disorder (SUD) Treatment. He stated that her advocacy led to Bi-Bett programs recognized as examples across the state.

V. <u>AOD Community Coalitions.</u>
Panel Presentation.

Michael Collins opened the floor to introduce the panel presentation from four (4) Alcohol and Other Drugs (AOD) Community Coalitions. The presenters discussed their work in their respective communities. Participating in the panel were:

- Jacquelyne Vera, West Contra Costa County Alcohol Policy Coalition
- Jaime Rich, Alcohol and Drug Abuse Prevention Team (ADAPT) Lamorinda,
- Jenna Stewart, Monument Youth Drug and Alcohol Coalition
- Patty Hoyt, Alcohol and Drug Abuse Prevention Team (ADAPT) San Ramon Valley

Some of the key themes from the presentation were as follows:

- Isabelle Kirske stated that there are two main types of strategies funded through Alcohol and Other Drugs Services (AODS), Education and Environmental Prevention, she clarified that coalition work is focused on the community as a whole.
- Isabelle shared an example to further explain Environmental Prevention. A person's decision to drink alcohol is influenced by a combination of factors: Individual Factors (the person's belief about alcohol), Environmental Factors (how well-accepted drinking is in the community), and the Agent Factors (which is the alcohol product, pricing, content, promotion, placement, etc.).
- Jacquelyne shared that she is new to her position and her coalition, which is based in Richmond, and they will have the first meeting in April. She added that there are more liquor stores in the community than grocery stores. As part of developing the coalition, she is currently completing one-on-one interviews to better understand community AOD-related issues.
- Jaime shared that her coalition covers Lafayette, Moraga and Orinda in which high pressure and stress can cause youth to use substances as coping mechanisms. ADAPT Lamorinda has hosted an RBS training for all alcohol servers at Saint Mary's College and has

- worked with the Chief of Police in Orinda, Lafayette and Moraga to separate instances of juvenile crimes with its own separate code for tracking purposes.
- Jenn's coalition covers the Monument Corridor in Concord which is a lower income, primarily immigrant community. She added that the California Healthy Kids Survey data showed that youth substance use in Concord is higher than the state average. Because the community is oversaturated with alcohol outlets, she has been working with code enforcement officers to ensure that alcoholic products are not sold near youth friendly items such as candy or soda. The coalition has successfully removed some alcohol advertisements from the windows of some of the problem outlets in the area. Most recently, the coalition developed a needs assessment survey to understand adult perception of harm related to alcohol, marijuana and prescription drug use.
- Patty explained that in the San Ramon Valley substance use in the home environment is prevalent. To address home parties, the coalition is currently updating the Social Host Ordinance to include marijuana. The schools within the San Ramon Valley are also hosting Wellness Days, in which the coalition will be providing information on Substance Use Disorders (SUD) Prevention to the students.
- As members of the California Alcohol Policy Alliance (CAPA) Jaime and Patty have gone to Sacramento to educate decision makers about the harms of bars or restaurants being able to serve alcohol until 4am. They have also attended quarterly meetings with the Alcoholic Beverage Control (ABC) to discuss Responsible Beverage Server (RBS) trainings since there is a statewide mandate for servers to receive the training going into effect at the beginning of next year.

VI. AOD Staff Report

Fatima Matal Sol submitted the Staff report in writing as requested by the Executive Committee. She made herself available for questions and highlighted the following items:

 Fatima shared that Bi-Bett is one of the largest providers in the county of which Susan Cinelli was the Executive Director. Upon Susan's passing AODS administration

has been regularly visiting the facilities to ensure that the programs are running smoothly. She added that AODS has worked with the Board of Bi-Bett to appoint a former AOD Administrator to assist as a consultant during this transitionary period, and assured the Board that AODS will ensure that Bi-Bett's programs remain operational as they look for a permanent solution.

Guita Bahramipour shared that the chair of the Mental Health Commission is leading the community interview panel for the new Behavioral Health Division Director. She stated that the AOD Advisory Board is a part of this community interview panel.

Alcohol License Initiatives. None.

Discuss SB 58 (Wiener) Alcoholic beverages: hours of sale. Vote in March.

There are no new alcohol license requests or applications.

Michael Collins opened the floor to discuss SB 58 (Winer), Alcoholic beverages: hours of sale. He asked Isabelle Kirske to share a few key points on the legislation as summarized by CAPA:

- This bill is similar to a past bill that the Advisory Board recommended the Board of Supervisors take a position of opposition on last year, SB 905. SB 58 (Wiener) would extend alcohol sales in nine (9) locations: San Francisco, Oakland, Sacramento, Los Angeles, Cathedral City, West Hollywood, Palm Springs, Long Beach, and Coachella.
- Despite this bill directly affecting only nine

 (9) cities, data has shown that 76% of the
 state's population would be affected by this
 legislation, because people who drink
 alcohol do not stay in one place.
- According to the Center for Disease Control, California already suffers more annual alcohol related harm than any other state: over 10,500 alcohol related deaths, \$35 billion in total costs, and \$14.5 billion in state costs.

Opportunity to purchase land in Richmond to be used as Recovery Residences. Discussion.

Antwon Cloird shared that the City of Richmond is removing a lot of housing in North Richmond and he believes that AODS would be able to purchase some land to build much needed Recovery Residences. He also explained that Contra Costa County is considering giving 2,000 more Section 8 vouchers from the Housing and Urban Development (HUD) program to the Martinez Housing Authority to be used in areas like Richmond.

- Tom Aswad thanked Fatima Matal Sol for her assistance in the meetings between Support4Recovery (S4R) and the Sober Living Environments (SLE) which are working together to create their own guidelines. Tom also shared that in January 2019 and February 2019 S4R approved 19 housing grants and they are expecting to approve between 90 and 100 grants by the end of 2019.
- Fatima Matal Sol stated that AODS will be conducting site visits on SLE's similar to treatment and prevention programs. She added that during a recent site visit she was happy to hear clients discussing continuing treatment and moving between the different ASAM levels of care from residential treatment to outpatient.
