### IV. PUBLIC COMMENT

The public and Board members may comment on any agenda item of public interest within the jurisdiction of the Alcohol and Other Drugs Advisory Board. (Maximum three minutes per speaker.)

- Jonathan Ciampi shared that he recently competed in a 10K run, and upon finishing the race he came across a booth selling cannabis liquids. He shared that he was shocked to see a cannabis samples tent at the end of the run.
- Michael Collins shared that the hospital he works at admitted a patient that brought their CBD oil that they use for pain management. He shared that he contacted

the patient's doctor and pharmacist and no one knew the proper dosing of the product or how to monitor it. Michael reported that instances like this are happening more frequently as cannabis use is becoming more accepted.

 Tom Aswad reported that as of May 22, 2019, Support4Recovery (S4R) had awarded 55 Sober Living Grants. He shared that the majority of the grants awarded, 38, are from the contract that S4R has with Alcohol and Other Drugs Services (AODS), the others were sponsored through grants to S4R.

V. <u>AOD Women's Services.</u> Panel Presentation and Q&A. – Trisha Seastrom\*

\*The Board continued with the agenda as approved.

Erika Jenssen, Assistant to the Health Services Director, shared that the Health Services Department chose the new Behavioral Health Director based on the recommendations of the two interview panels. Their appointment was approved by the Board of Supervisors on May 21, 2019. Erika shared that Dr. Suzanne Tevano will be the new Director of Behavioral Health Services effective June 1, 2019. She thanked Victor Ortiz and Tom Aswad for their involvement in the interview process. Erika also thanked Dr. White for all of his work as the interim Behavioral Health Director.

Fatima Matal Sol introduced the Women's Services panel participants. Some key points from presentation were as follows:

- Shana Lynch is a Substance Abuse Counselor with the Substance Abuse and Mental Health Work Opportunity and Responsibility to Kids (SAMWORKs). She explained that these services are available for CalWORKs participants. She stated that she works at the Employment and Human Services Departments (EHSD) throughout the county providing Alcohol and Other Drug screenings for CalWORKs Welfare to Work participants.
- Joni Lacey, is a Coordinator of Wollam Services in Pittsburg. She shared that Wollam House provides services for multiple levels of care such as Residential Treatment and Detox Services.
- Lani Lopez, is a Coordinator of La Casa which is a part of Ujima and she shared that they offer residential treatment in San Pablo and Martinez as well as outpatient treatment. She stated that there needs to be more sober living options for women with children.
- Fadua Galdamez is the Latino(a) outreach specialist for SAMWORKs and she shared that she connects people with the services

- they need.
- Mickie Marchetti is the Executive Director of REACH Project where they provide a program entitled the Family Wellness Program through a contract with SAMWORKs. He shared that REACH Project provides individual and family counseling for up to six (6) months, and if needed they can extend the counseling services up to one (1) year as a part of the Family Wellness Program.
- One panel member shared that there are instances where women would rather be homeless then to go to a homeless shelter. The shelters need to be more supportive of individuals who are working on maintaining their sobriety.

VI. AOD Staff Report

Fatima Matal Sol submitted the Staff report in writing as requested by the Executive Committee. She made herself available for questions and highlighted the following items:

- Fatima shared that AODS just completed their annual site visit with the Department of Health Care Services (DHCS). She stated that AODS has reduced their deficiencies to three (3), which are all connected to data.
  - The largest data related deficiency is from the methadone clinics.
  - Another deficiency is related to AODS not contracting with enough clinics that provide buprenorphine.
- Fatima stated that on May 1, 2019 AODS received notification that ANKA filed for bankruptcy. ANKA has provided Behavioral Health Services throughout Contra Costa as well as other counties. Fatima has worked with CenterPoint to have them take over the two ANKA locations, Concord and Richmond.

#### XI. PUBLIC COMMENT

Michael Collins opened the floor to discuss the alcohol license application for Abuelita's Market. Some key discussion items are as follows:

- The community of Bay Point is oversaturated with alcohol outlets.
- Hector Jaimes shared that he is with the Reentry Network and that he was working with a client waiting to get into Discovery House. He said that this client preferred to remain on the street instead of going to a wet homeless shelter. He stated that anything the Board can do to address the topic of wet shelters would be appreciated.
- Tom Aswad reminded the Board that S4R worked with a client who graduated from Discovery House and chose to live on the street as a means to remain sober.
- Fatima Matal Sol shared that Health Services is beginning a Strategic Planning Process for the Waiver 2020. The Board was invited to participate in the process.
- Jonathan Ciampi shared that each city has a leadership development program in which community members can learn about the different aspects of city government. He stated that the leadership group he is working with focused on Narcan availability and they trained store employees on how to administer Narcan. Finally, Jonathan shared that National Public Radio (NPR) conducted an interview with the leadership group that will be shared on May 30, 2019.
- Guita Bahramipour shared that she attended a luncheon with pharmacists where she learned that they can be held accountable for filling too many opioid prescriptions. She stated that she would be interested in inviting a pharmacist to present to the Board.
