# V. ALCHOHOL BEVERAGE CONTROL TEMPORARY REGULATIONS - Presentation by AODS Prevention System of Care Representatives

Jaime Rich from the Center for Human Development along with Patty Hoyt from Discovery Counseling Center presented on Alcohol Beverage Control's (ABC) temporary regulations on alcohol deliveries.

Temporary regulations were put in place due to the COVID-19 Pandemic, which allows 3<sup>rd</sup> party alcohol deliveries (i.e. Uber Eats and Door Dash). Data shows that there has been an increase in alcohol sales and consumption since 2019. ABC has been conducting minor decoy operations that resulted in a 79% failure rate in April 2020 and a 35% failure rate in August 2020. The failure rate demonstrates that alcohol is being delivered to minors. Locally, the City of Danville's minor decoy operation resulted in a 56% failure rate in May

Jaime and Patty are advocating for these regulations to remain temporary and are actively seeking solutions that ensure alcohol is not being delivered to minors via 3rd party deliveries.

Board members discussed possible solutions and actions that can be brought to the Board of Supervisors to address the issue. Board members discussed endorsing a letter written to the Board of Supervisors. Fatima recommended this discussion be deferred to the Executive Committee for follow up as a decision cannot be made today.

#### VI. <u>AOD STAFF REPORT</u> Fatima Matal Sol

Fatima Matal Sol submitted the staff report in writing as requested by the **Executive Committee and made herself** available for questions. Funding has been secured for youth outreach, navigation and treatment for Central County and West County via a new contracted provider, La Familia, which is a Drug Medi-Cal provider in Alameda County. The Juvenile Justice Coordinating Council recommended more funding for this initiative. In addition, there has been a decline in women's treatment referrals. AODS will be conducting outreach and navigation with organizations, such as Children and Family Services and the Family Dependency Court. Fatima stated that positive COVID-19 cases have continued to increase. The

Health Services Director sent an email stating that Contra Costa County received COVID-19 vaccines and they will be distributed to first responders as the initial priority.

Currently, four treatment programs are dealing with COVID-19 outbreaks although safety protocols are reportedly being followed. As a result, the intake process is slightly delayed due to the 14-day quarantine. This also impacts the PUI hotel as clients are tested and sent to the PUI hotel to wait for test results and admission to treatment.

The Transition Team is being redirected as well as some counselors at the Mental Health Access Line to implement interim telephonic services for clients needing to enter treatment.

AODS is preparing for the annual Department of Healthcare Services (DHCS) audit. The deadline for documentation submission was December 17<sup>th</sup>, 2020 and the actual audit will take place virtually in March 2021.

Fatima had a call with ~40 SLE's to provide information on how to handle COVID-19 outbreaks and is working with Public Health on how to reach the SLE's that are not monitored by Contra Costa County.

It was discussed how the Board can work with the Community Advisory Board (CAB) to ensure that SLE's provide the support that clients need.
