David Seidner, MH Program Chief and Dr. Sonia Sutherland, MD Interim Medical Director presented power point slides

health and medical health areas at the Martinez and West County jails, to improve treatment of inmates. Improvements made to date, David Seidner, Mental Health Program Chief, Dr. Sonia Sutherland, Interim Medical Director, Shanta Ramdeholl, Chief of Nursing, Detention Health Services Team (30 minutes)

about Detention Health's Response to the Contra Costa Prison Law Office's Negotiations that started in 2017 and the Consent decree which was approved in that included February 2021 negotiated Medical and MH remedial plans to give patients standards of care. In 2017, a Value Stream Mapping was conducted and standards to track and evaluate were established, those included a medical evaluation and treatment for arrested patients along with a referral to a nurse/MH specialist depending personal history and risk factors. In addition, a Suicide Prevention Program was implemented to decrease the large number of suicides that were occurring at the time. Furthermore. David said that Medication Assisted Treatment (MAT) was also added for individuals with mental health and substance use issues. Dr. Sutherland added that Detention work is not completely new to her and that over the last 4 years while she was a Medical Director to the hospital, she was assigned to Detention and regularly collaborated with custody. This was an effort to provide better care to individuals transitioning from jail to hospital and vice versa. Contra Costa was one of the first counties to start COVID19 vaccinations of all inmates, and thus far; they have given 950 doses. David Seidner referred to the prescription of Narcan upon release due to Fentanyl exposure. The Advisory Board asked if there were services for Spanish speakers in the Jail. Tom and Fatima thanked David Seidner and Dr. Sonia Sutherland for their presentation.

STAFF REPORT Fatima Matal Sol

Fatima introduced the following new staff to There were no questions for staff the Board: Sonya Blunt, Substance Abuse regarding Staff Report Supervisor and Lashondra Goode Perinatal Services -Perinatal Services and Substance Abuse Counselor (SAC). Lacreena Williams is a SAC who will start on June 28 and will be assigned at West County Detention, Dora Muñoz, will work with clients who complete Pueblos Del Sol and all Spanish speaking clients. She is an addition to the two bilingual Counselors at the Access Line. Jayme Shipe is the new Prevention Coordinator and she will be supporting the Advisory Board meetings. Jonathan inquired about who will be taking the place of Christopher and running Discovery House, Fatima answered that for the time being and until a replacement is found she is doing it herself as Christopher transferred to Behavioral Health Division; however, until his role is clearly finalized

Fatima reported that the Department of Corrections had communicated that Contra Costa was awarded the grant for treatment in the jail and thanked all of those who had provided a letter of support including the Sheriff Office. Tom Thanked the Sheriff Office and recommended that a letter thanking the Sheriff should be sent on behalf of the Board.

Jonathan stated that the committee discussed today's presentation and updated the Board's Action Plan. He encouraged all Committees to submit updates to Vic Ortiz and stressed the importance of reporting progress. Jonathan also highlighted the importance of meeting regularly. Discussion ensued about challenges meeting on a monthly basis due to lack of staff. Fatima stated that if the chair submits the agenda on time, accommodations can be made to meet monthly until the committee is up to date on its goals and objectives.

<u>Community Awareness</u> – Guita Bahramipour, Chair

Guita said that she is preparing for the meeting with the Office of Education to discuss kids using drugs and alcohol on school campuses; she has concerns about the importance to monitor school bathrooms. Other discussion topics will include alternative ideas for detention or suspension. Instead of being sent home, students should be given a referral for drug treatment. Current strategies are not working for displacing students for drug use.

The ceremony for People Who Make a Difference Awards will be on July 13 at the Board of Supervisors Meeting. This will be a virtual presentation.
