

Behavioral Health Issues Treatment of Consumers, Family Members at PES, Miller Wellness Center Consumer Input on Mental Health Electronic Records 	 CPAW members and guests had an open discussion with Matthew Luu, Deputy Director. An individual identified as a transgender youth went to PES and PES identified the youth with a red bracelet stating "Transgender." The individual was not referred to by the name they identify with but referred to by their birth name. Individual does not want to return to PES due to the treatment they received. The sensitivity training that was provided to the PES staff was not of the caliber provided by that available by Rainbow Community Center. When the Miller Wellness Center was created, it was to be used as a diversion from PES; but since the Miller Wellness Center is a FQHC, only the mild to moderate individuals are treated. Individuals who go to PES are usually experiencing moderate to severe mental health issues. CPAW Member, Ashley, had an 		Matthew Luu

	experience at PES. She went to PES and expressed that PES feels like a prison. The staff took an hour before trying to assist her, and told her that she needed to go to the Miller Wellness Center. The Miller Wellness Center is not open at 12:00 am. The PES staff offered for her to "hang out" at PES, but they would have to bill her for staying there. • PES has 21 beds available, and is too small for the volume of individuals treated there. • Over 5 years ago, the county was processing 350 individuals at PES. Currently they are processing 900 individuals at PES. The layout of PES has not changed over the last five years. • The Suicide Prevention Committee is trying to address the issue of what are the options before an individual goes to PES. • There too many waiting lists at the clinics. • There is not an inpatient children's unit. • There is no crisis residential program in the county for children or young adults. • Individuals are not able to get appointments at county clinics for

	 over two months. Miller Wellness Center provided a refill prescription and then the individual received a bill for the service. The individual did not receive a clear description of what is being billed. Is there a possibility that the individual does not receive the bill but maybe the full service partner receives the bill? Individuals should be provided the information for the Suicide Hotline. PES Staff do not know if an individual is suicidal unless the individual tells the staff. The PES staff took the individual for granted. During the EQRO audit, it was noted that the after-hours calls to Access Line would roll over to PES and PES is not always available to answer the calls. Optum has contracts with other counties within California. How has the Optum system improved the call in system after hours? Individuals have concerns about the confidentiality of the Electronic Health Records. Can a doctor have access to mental health records during a primary care visit? 3. Proposal to amend the	 individuals have the opportunity to ask questions about the information presented. Concerns/thoughts about information sharing and confidentiality of each consumer's record. Consumers would like to provide input. Some individuals go to two different locations to keep their records separate. A location will be used for primary care and a second location will be used for mental health care. It should be up to each individual if their information integrated. There is a suggestion to have the individual sign a form agreeing to the integration. Doctors may have their hands tied if they do not know the medication an individual is currently taking to understand the individual's diagnosis. The county system requires an individual to sign a release of information form. Privacy is very important to all individuals; but the medication piece is very important to ensure a doctor is not overprescribing medication.
