## Mental Health Services Act (MHSA)

- Proposition 63 voted into law in November 2004 by California's citizens.
- · Taxed 1% of income over \$1 million.
- Provides additional funding to the County's existing public mental health system of care.
- Services are to be consumer driven, family focused, based in the community, culturally competent, and integrated with other appropriate health and social services.
- Requires that a three year program and expenditure plan be developed with the active participation of local stakeholders in a community program planning process.



#### MHSA Three Year Program and Expenditure Plan

- Contra Costa's Three Year Plan was approved by the Board of Supervisors for FY 2017-20.
- Preceded by a comprehensive community program planning process
- Approximately 280 consumers, family members, service providers and other interested individuals participated in three community forums that identified service needs, and offered strategies for meeting these needs.
- We are asking for your input as we prepare our annual MHSA Plan Update for the upcoming fiscal year.



#### Plan Update

For Fiscal Year 2018-19 the Three Year Plan set aside \$50.5 million for over 80 programs and plan elements in the following five components:

- Community Services and Supports \$36.8 million for children with serious emotional disturbance and adults with serious mental illness
- Prevention and Early Intervention \$8.9 million for services to prevent mental illness from becoming severe and debilitating
- <u>Innovation</u> \$2.2 million for new or different patterns of service that can be subsequently added into the system.
- Workforce Education and Training \$2.6 million to recruit and retain CCBHS County employees and contract staff.
- <u>Capital Facilities/Information Technology</u> \$50,000 toward implementing an electronic mental health record system.
