Highlights of news to share and areas discussed at recent Contra Costa Behavioral Health Services (CCBHS) supported stakeholder meetings:

Adult Committee

Aging and Older Adult Committee (January 27th, February 10th)

January 27th

- On 1/27/21, we received an update on the COVID-19 Vaccine from Erika Jenssen, MPH, Deputy Director of Contra Costa Health Services. We also discussed opportunities for volunteering and the Adult Ambassador positions that were soon to be filled.
- In addition, we updated the group on completed and ongoing outreach projects, including the custom print masks, and the Valentine's postcard campaign. Custom print masks in English, Spanish, Tagalog and Nepali were distributed to community partners. These masks included the message, "Stay Safe Stay Connected Contra Costa!" and included the phone numbers for Information & Assistance for Older Adults and the hotline for reporting to Adult Protective Services. Valentine's Day postcards will be printed with an uplifting message. They will also include the website and Call Center information to register for the COVID-19 vaccine. Discussed the plan to distribute these postcards to Meals on Wheels and other community partners.
- Discussed the upcoming presentation from Gilbert Salinas, Health Equity Officer, on the COVID-19 Vaccine and the topics that the workgroup would like Gilbert to cover.

February 10th

- On 2/10/21, the workgroup was encouraged to attend a presentation hosted by the Ombudsman's Office on Seniors and the COVID-19 Vaccine, which was scheduled for the same time as the workgroup meeting.
- Following this webinar, the workgroup held a brief meeting to provide updates on outreach projects, and discuss plans for the upcoming presentation from Gilbert Salinas, Health Equity Officer. Gilbert will be presenting during the meeting on 2/24/21 from 2pm to 3:30pm.

Behavioral Health Care Partnership (BHCP) (February 16th)

- Received an update from Psychiatric Emergency Services about the current process on 4C & 4D
 pertaining to COVID-19 vaccinations. The vaccine will be offered and administered to those who
 fit the current criteria. For those that receive the first vaccine and are going to be transitioning out
 and or transferring to another location for further treatment, the second vaccine will be
 coordinated with client's treatment team.
- Listened to input regarding a minor and parent/caregiver's recent visit to Miller Wellness Center. It was difficult to navigate through the tents and lines which are set up to administer the vaccines. No privacy and embarrassing for the family experiencing a crisis.

- The partnership spent the latter part of the meeting in breakout groups examining aim statements pertaining to the crisis intervention services work to improve our community crisis response services here in Contra Costa County. The BHCP co-instructors summarized the feedback and shared the input and a few aim statement recommendations with the Crisis Response Design Team.
