(CPAW Meeting - April 1, 2021)

Highlights of news to share and areas discussed at recent Contra Costa Behavioral Health Services (CCBHS) supported stakeholder meetings:

Adult Committee

· Meetings canceled until further notice.

Aging and Older Adult Committee (February 24th, March 10th)

February 24th

- We received an informative presentation from Gilbert Salinas, Health Equity Officer, and Dr. Mekuria, Deputy Health Officer, on the COVID-19 Vaccine Rollout in Contra Costa County, which included time for several questions and answers. At the time of the presentation, 81% of Contra Costa residents, who are 75+ had received at least one dose of the vaccine, and 54% of Contra Costa residents, who are ages 65-74 had received at least one dose of the vaccine.
- We discussed the mobile vaccine clinics that have provided vaccinations at 70 affordable senior housing units and discussed efforts to increase outreach to East and West County.
- We discussed the COVID-19 Vaccine Call Center 1-833-VAX-COCO, which is able to utilize
 the Language Line and assist with setting up transportation for vaccine
 appointments. Discussed transportation barriers for older adults, and resources, including
 Mobility Matters, which provides door to door service.
- We discussed efforts to develop a strategy to reach out to frail isolated older adults who are not able to leave their homes to provide the vaccine. Discussed issues related to equity among communities of color and vaccine distribution.
- We discussed the Adult Ambassador Program, and how these Ambassadors could assist with outreach to older adults.

March 10th

- On 3/10/21 we received a presentation from the MHSA Team, and were given an opportunity to provide feedback in small breakout groups on community priorities for mental health resources.
- We discussed possible future outreach projects, including a collaboration with the Family Justice Center on Public Service Announcements. We received an update on plans for an outreach event in East County, which will provide resources and possibly a mobile vaccine clinic. Also discussed possible future presentation topics.
- Our next meetings are scheduled for 3/24/21 and 4/28/21 from 2pm to 3:30pm.

Alcohol and Other Drugs (AOD) Advisory Board (January 30th, February 24th)

 The Alcohol and Other Drugs (AOD) Advisory Board met on March 24th. Since the meeting is held late in the month, the summary of the meeting could not be provided in time for inclusion in this Stakeholder Sharing. Provided below is the summary of the January and February meetings. The summary of the March meeting will be provided in April.

January 30th

- **Board Officer Position Elections –** Elected and approved were Jonathan Ciampi as Chair and Victor Ortiz as Vice Chair of the AOD Advisory Board.
- Old Business The Alcohol Beverage Control's (ABC) temporary regulation that permits third party alcohol deliveries (due to COVID-19 Pandemic) has resulted in alcohol being delivered to

- minors. The Board reviewed a letter that highlights this issue and advocates for community groups to go to ABC and Board of Supervisors.
- **New Business -** Discussion of a letter written by Support4Recovery with regard to the challenges experienced by clients at the Person Under Investigation (PUI) hotel. The PUI hotel is where people who are entering treatment and are suspected of contracting COVID-19 are being held. The Board agreed to draft a letter of support at the Executive Committee meeting.
- Alcohol and Other Drugs Services (AODS) Operations (Part 1 and 2)
 - This is a planning meeting to identify issues/opportunities that the Board can solve with the goal of developing the annual plan for 2021. The Board strives to have adequate methods for input that lead to viable recommendations for a meaningful impact in the community even during the challenges of the pandemic.
 - o Fatima Matal Sol gave an overview of client centered goals and operations for AODS
 - o La Familia will provide adolescent treatment and outreach in Central and West County'
 - o There has been an increase in outpatient and intensive outpatient treatment services
 - AODS continues to monitor and audit provides to assess quality of services
 - Discussed the Client COVID-19 Online Survey that evaluates the client's experience with receiving services
 - Goals for the Board to consider prevention, stigma reduction, continue to inform and educate AODS on what is happening in the community, continued support of adolescent treatment, continue to advocate for integrated care and mental health treatment and support of treatment in the jails.
- **Committee Workgroup Sessions** Each committee reviewed, discussed, and modified the 2021 Action Plan.
- **Debriefed Committee Action Plan with Full Board -** Various committees detailed committee goal and committee plans.

February 24th

Staff Report

- Currently there is a limited supply of vaccines and the County is awaiting shipment.
- At AODS Administration, more staff are beginning to return to the office on a rotational schedule
- Concord Mental Health Clinic is running groups and the Transition Team will be working in the field as well remotely
- The Motel 6 in Pittsburg was purchased by the County and will continue to providing services there and when ready, at the Concord Shelter
- Most County health workers have received the second dose of the vaccine.
- There has been a decline in community outbreaks
- All Medi-Cal beneficiaries will have access to roundtrip rides to and from health-related appointments
- Encouraged inviting La Familia Counseling Center (will provide services in Concord and Richmond) to present at the next Board meeting
- Committee Highlights Executive Committee discussed topics for subcommittees.
- Liaison Reports Received updates from the MEDS Coalition and Sober Living.
- Old Business Agreed to write the letter of support in regard to those in PUI hotels.
- New Business Discussed the Action Plan and AOD Care Process Flow

Behavioral Health Care Partnership (BHCP) (March 16th)

- Behavioral Health Care Partnership met on March 16th, 2021 from 1:30PM-3:00PM via Zoom online/telephone conference.
- We received an update on Psychiatric Emergency Services and the current process on 4C & 4D
 pertaining to COVID-19 and the vaccination process. The vaccine is now available to those that
 wish to receive it that meet the eligibility requirements, on 4C & 4D and had been administered
 with more scheduled.
- It was stated by leadership that there is a plan to set up a way to have the vaccine administered within our Behavioral Health clinics, since there are many clients who utilize Behavioral Health services who will not go to a public health clinic and otherwise would not receive the vaccine.
- There was discussion around the "Understanding the Vaccine Through Cartoons" Booklet which
 was illustrated by Dr. Emily Watters and put into the form of a booklet with the help of the Office
 for Consumer Empowerment and our Print & Mail Services. The booklet is offered in English and
 Spanish.
- We were given an update that we have no word yet on the grant pertaining to a standalone unit
 for children and that as a plan B we would need to find a way to build it into the budget or look
 into the possibility of obtaining funds from Measure X.
- Lastly, we received an update on the Rapid Improvement efforts regarding crisis response and learned about the Miles Hall Lifeline Act aka SB 988 legislation.
- The next Behavioral Health Care Partnership meeting is scheduled for April 20th, 2021 from 1:30PM 3:00PM via Zoom online/telephone conference.

Children, Teens and Young Adults Committee

Update will be provided at the CPAW meeting.

Health, Housing and Homeless Services (H3) (March 4th)

- COVID-19 Vaccination for Consumers beginning, with J&J vaccine
- Bay Area Community Services (BACS) was awarded full allocation of \$3 million for Rapid Rehousing (RRH) for residents of Project Roomkey hotels
- \$71 million of Emergency Rental Assistance Program (ERAP) funding to be distributed through the state who will partner with Local Initiatives Support Corporation (LISC) who will work with local providers to distribute the money to Contra Costa residents
- Contra Costa Housing Authority opened up a Project Based Voucher list for Terraces, a senior development in Richmond in November. Opened list March 22nd and noted that they have 3-4 bedrooms to fill and that the definition of "family" can be fairly flexible for this voucher.
- The next Council on Homelessness meeting is April 1st from 1:00 3:00 pm.
- The next H3 Learning Hub meeting will be Monday, May 10th

Innovation Committee (March 22nd)

 The Center for Recovery and Empowerment (CORE) project's Program Supervisor has left her position with the County and the program. Remaining project staff will be placed at the West Contra Costa County Children's Clinic. Remaining staff will continue to see clients assigned to the project

- The Cognitive Behavioral Social Skills Training (CBSST) in Augmented Board & Cares is providing individual services as needed.
- Discussed projects sunsetting in September and the process to start new innovations projects.
- The next meeting is scheduled for Monday, May 24th from 2:30pm to 4:00pm and will be via Zoom. Zoom link will be sent out a week before the meeting.

Mental Health Commission (MHC) (March 3rd)

- Received a presentation by Gerold Loenicker, Chief of Behavioral Health Services Children's Division, regarding a grant application for funds for a potential new Children's/Youth Crisis Stabilization Unit (CSU) and other Division.
- Received a presentation on the mental health work of the Jewish Family and Community Services with Afghan refugees and immigrants in Contra Costa County; Lisa Mulligan, Refugee Mental Health Coordinator, Jewish Family and Community Services - East Bay and Fouzia Azizi, Department Director, Jewish Family and Community Services - East Bay.
- Voting on Bylaw changes were postponed to the April Executive Committee meeting to be on the agenda for the MHC May 2021 meeting.
- Voted and passed 2021 Commission-wide goals:
 - o Contribute to crisis intervention efforts.
 - Create a plan for smoking cessation.
 - Create a plan for value stream mapping event to increase the number of beds (recommendations from Housing that Heals).
 - o Create a plan for value stream mapping event for conservatorships.
 - Site visit goals (set number of site visits to perform).
- The next Mental Health Commission will be April 7th from 4:30 6:30 pm via Zoom.

Quality of Care Committee (QC) (March 18th)

- Reviewed/discussed list of Mental Health Services Act (MHSA) funded facilities and programs, Behavioral Health Services (BHS) owned and operated facilities, and contracted facilities for children and transitional age youth (TAY). Topics to include priorities for site visits, size of facilities and typical number of county clients. Jennifer Bruggeman, MHSA Program Manager, and Gerold Loenicker, BHS Children and Adolescent Program Chief
- Reviewed/discussed Site Visit report instructions and template updates.
- Discussion on HUME Site Visit test status.
- Discussion regarding sources and strategies for identifying health care insurance company representatives for discussion of mental and physical health parity.
- The next Quality of Care Committee meeting will be April 15th from 3:30 5:00 pm via Zoom.

- The Suicide Prevention Committee met on March 26th via Zoom. Since the meeting is held late in the month, the summary of the meeting could not be provided in time for inclusion in this Stakeholder Sharing. - There was a presentation from Dave Fendel, Coordinator for Social Emotional Learning Support from the Office of Education regarding support for youth.
- The Youth Sub-Committee met for the second time directly after the larger coalition meeting. At
 this meeting Blanca Gutierrez, 211's Resource Manager, gave a presentation on updates 211 is
 making to their online resource guide to ease access to information. They are also building out
 the site's functionality with regarding to suicide-related resources. More to come on that as it
 continues to be revamped.
- Both groups will hold their next meetings on 3/26/21. The Coalition will meet from 9-10:30am and the youth sub-committee will meet from 11am-12pm
- Avani Gireesha, a student at Venture High School and Founder of Not The End, will be presenting at both meetings.
- In addition, at the larger Coalition meeting, we will be sharing information on WellSpace Health's ED Follow Up program and reviewing the Suicide Prevention RFP scheduled to go out next month, for final input. The Youth Sub-Committee will also be continuing the discussion around goals for the group, including ways to diversify the participants.
- The next Suicide Prevention Committee meeting will be Friday, April 23rd from 9-10:30 am and
 the Youth Sub-Committee meeting time is TBD. We will be discussing when will be the best time
 of day to meet moving forward so we can be more inclusive, particularly to youth who would like
 to join in the conversation but can't midday due to school schedules. The committees will meet
 via Zoom.

System of Care Committee (March 10th)

- Received a presentation from Leslie Garcia (Director of Programs) and Tom Tamura (Executive Director) on the Contra Costa Crisis Center and suicide prevention efforts.
- Reviewed the Suicide Prevention Request for Proposals (RFP). Responded to questions and received input. The RFP will be discussed again at the upcoming Suicide Prevention Committee on March 26th. Anticipate issuing the RFP in April.
- Received Public Comment and input for future Committee Agenda items.
- Meetings are currently being held every other month. Next meeting is scheduled for Wednesday, May 12th from 10:00am to 11:30am via Zoom.









Good News for Contra Costa! ©

- As of 3/2/21 (per Dr. Farnitano, Health Officer) -
 - 86% of Contra Costa County adults 75+ have received at least one does of the COVID-19 Vaccine
 - 60% of Contra Costa County adults 65-74 have received at least one dose of the COVID-19 Vaccine
 - 24.5% of the Contra Costa County population has received at least one dose of the COVID-19 Vaccine
 - In the past there have been up to 60 active outbreaks in congregate care facilities. This number is now down to 10 active outbreaks.
 - Many older adults have been vaccinated through mobile vaccine clinics!
