MHSA Consolidated Planning Advisory Workgroup (CPAW) January 6, 2022 Meeting

Highlights of news to share and areas discussed at recent Contra Costa Behavioral Health Services (CCBHS) supported stakeholder meetings held in December 2021:

Adult Committee

• Meetings canceled until further notice

Aging and Older Adult Committee (AOA) (December 8, 2021)

- The Older Adult COVID-19 Workgroup met on 12/8/21. We engaged in planning around distributing holiday postcards. These postcards were printed in English and Spanish. They include information on the COVID-19 Vaccine and Booster Shot, as well as info on 211 as a resource for anyone experiencing isolation. 250 of the postcards included pre-paid postage so that an isolated older adult could use this postcard to reach out to a friend or family member. Discussed several community-based organizations that would receive these postcards as well as Behavioral Health clients.
- We also discussed plans to distribute approximately 200 handmade holiday cards made by local 1st, 3rd and 4th graders to isolated older adults living in Residential Care Facilities for the Elderly or Skilled Nursing Facilities.
- Discussed areas to focus on in 2022, including continued focus on COVID-19 and the
 Omicron Variant, housing for older adults, services for older adults with dementia,
 transportation difficulties for older adults, the Measure X Funds that have been allocated for
 the Seniors Accessible Transportation Strategic Plan, expanding our understanding of
 insurance benefits for older adults, and the implementation of the Master Plan for
 Aging. We shared resources and ideas related to these topics.
- Discussed the accomplishments of the workgroup during 2021, including producing a
 television commercial that provided information on the COVID-19 Vaccine and Vaccine
 Scams in English, Spanish, English with Tagalog subtitles, and English with Simplified
 Chinese subtitles. Additional accomplishments include distributing printed cloth face masks
 that included the Information & Assistance Phone Number and the Adult Protective
 Services Reporting Hotline in English, Spanish, Tagalog, and Nepali, and creating a
 collaborative group of people who are passionate about advocacy and service for older
 adults who can share resources and learn from and support each other.
- The next meeting will be January 26, 2022 from 2:00pm to 3:30pm via Zoom.

Alcohol and Other Drugs (AOD) Advisory Board (December 15th)

- Public Comment received. Fatima Matal Sol (AOD Program Chief) and AOD have partnered with Support4Recovery to organize "Clean Slate Day" to be held on Sunday, December 19th from 10:00 am to 3:00 pm. Is an event for adults to have criminal records expunged. Will also be offering COVID-19 vaccinations. The Mexican Consulate will be present to support Spanish speaking clients.
- Jill Ray announced the Board of Supervisors received the report from the Measure X Committee and they allocated ten million dollars to establish a local housing trust fund.
- Regarding treatment in the jails, AODS has made an offer to a manager and interviews for two counselors will be held. One counselor is on board now working in the jail.

- Fatima Mata Sol provided a brief background of the Opioid Settlement.
- Nominations for Chair and Vice-Chair were received.
- Committee membership redistribution discussed.
- The next meeting will be held January 26th, 2022 from 4:00 pm to 6:15 pm via Zoom.

Behavioral Health Care Partnership (BHCP) (December 21st)

- We further discussed the need to change the word patient in our mission statement. We will
 revisit this in meetings to come. It was suggested that the terminology that we decide on be
 used throughout our system to avoid confusion and that we get input on the change from
 stakeholders.
- We received in-depth updates regarding the progress with the development of the Children's Crisis Stabilization Unit and the efforts being made to ensure that the services currently being offered to adults at the Miller Wellness Center, can continue. Leadership are working out the details.
- An update was given on Measure X funds being awarded to Contra Costa Regional Medical Center (CRMC). A portion of the funds will be used to expand our Psychiatric Emergency Services (PES) Unit.
- We heard an update on the A3/Miles Hall Crisis Hub which is still taking calls on a limited basis. Measure X funding has been rewarded for this initiative. Development is underway.
- We received an update from CCRMC/PES leadership. It was mentioned that they are pleased to have received several "thank you notes" from those who have used their services recently.
- PES Visitation Guidelines during COVID-19: Must show proof of vaccination or a negative COVID test from within the last 72 hours and must call in advance to set it up. If there are any changes CCRMC/PES leadership will let us know.
- An update was given regarding the closure of Nierika House and Nevin House. The intent is to reinstate both as an adult transitional residential and a crisis residential treatment program.
- There was further discussion around the need for alternative destinations such as sobering centers and peer respite.
- The next Behavioral Health Care Partnership meeting is scheduled for January 18^{th,} 2022, from 1:30PM 3:00PM via Zoom online/telephone conference.

- Provided an update on the 2021-2022 Cultural Humility Plan, received input on Action Items and discussed submission of the Plan
