Aging and Older Adult Committee (AOA) (January 26th)

Alcohol and Other Drugs (AOD) Advisory Board (December 15th)

- The AOD Board will meet on January 26th. Due to the date of the meeting, a summary of the meeting could not be provided by the publication of this document. A summary of the January meeting will be provided in February.
- The AOD Board met on December 15, 2021.
- Received a presentation from the RichMinds Network which was started due to a need for resources for victims of gun violence. Held events at high schools. Works with Community Villages to assist the unhoused community, establish food security and provide mental health awareness.
- Presentation on Measure X Funding. AOD providers are part of the Human Services Alliance which is requesting two million dollars in funding. Due to COVID, have seen increased referrals for Substance Use Disorder (SUD) services. Need funding also for staff. Unallocated funds will be discussed by department heads to address gaps in service.
- AODS received a Covid Relief Grant for prevention providers to improve technology and for staff salaries. A grant will provide for Electronic Health Records (EHR) improvements.
- Provided updates on a new developing performance-based contract for providers.
