Alcohol and Other Drugs (AOD) Advisory Board (March 23rd)

- Mental Health recently closed Neirika and Nevin House crisis residential/stabilization facilities. Is an opportunity to redesign into a co-occurring (mental health and substance use) enhanced treatment facility.
- Department of Health Care Services (DHCS) allocated 2.2 million dollars for healthcare facility improvements statewide – the Behavioral Health Continuum Infrastructure Program (BHCIP). A community forum was held and am receiving input from the community. A proposal (application) for funding will be submitted based on this community input.
- Juvenile Hall pilot program started to screen youth and assist youth and families when transitioning back into the community (linked with La Familia services).
- AOD will have an outreach resource table at an upcoming vaccination clinic on April 7th.
- Provided an overview of the Peer Support Specialist (PSS) Senate Bill. CALMHSA (California Mental Health Services Authority) will become the certifying agency. May later qualify for Drug Medi-Cal (DMC) claimable service billing.
