#### Special Presentation by SelectCARE More Medicare and Medi-Cal Services CANCELLED

#### Budget Update/ RCEB Update – Jim Burton

- The state budget is at a stalemate in Sacramento with an \$8 to \$9 billion deficit.
- Discussion continues on the proposed 10% cut to supported employment.
- Our focus needs to be on changing the cost containment measures from permanent back to temporary.
- Budget hearings will be in April, and the May revision will be very important.
- March 5 was a very successful "Grassroots Day" with folks meeting with every Legislator.
- Agnews Closure Plan there are 8 remodeled homes in use for those consumers leaving Agnews the process is
  going slowly but it is being done right. Consumers are enjoying having their own home and bedrooms, and families are
  becoming more supportive as they see it unfold.
- SB1175, which will make more homes available throughout the state similar to those owned by the Housing Consortium of the East Bay, was heard in the Assembly and passed 5-0.
- East Bay Legislative Breakfast is April 18 at 8:00 a.m., and provides an opportunity to meet with local staff of local legislators.

#### **Committee Reports**

### Family Support – Betsy Katz

Will be sponsoring two forums a year where parents can connect with each other. One will be held in Central/East County, and the one in West County. They have received funding of \$850 to secure facilities, publicity, etc., for the forums.

#### Legislative Committee - Will Sanford

- AB 2424 hearing is set for April 2, 2008, and it could have a huge impact if it passes.
- The Department of Rehab has requested a 10% decrease in Supported Employment. The Supported Employment Coalition is working hard to prevent this from becoming law.
- Leginfo.ca.gov is a great webpage to help track the progress of any bill.
- Gina has recommended that she draft a letter to legislators explaining the DD Council's position on general cuts,
  AB2424, recommended 10% cut to supported employment, etc. This recommendation passed unanimously (motion by
  Pat Yamamoto and second by Penny Musante). Individuals were still encouraged to write letters to our legislators on
  these important issues.
- San Francisco believes that the 10% reduction in physician rates was not done legally, and is suing the state. It was suggested that perhaps we could collaborate with S.F. if they pursue a class action suit against the state.

#### <u>Transition Committee</u> – Penny Musante

- The Transition Fair will be held at Marcus on April 13 from 9:00 a.m. to noon.
- They had a meeting last Tuesday with a very inspirational speaker on Autism.
- The MDUSD is starting an Autism group.
- Penny took the Community College Group to "On Your Own" where they learned about budgeting and facts of real life.
- The West County Transition Fair will be held on April 12 at Vista Hills Center from 10:00 a.m. to 1:00 p.m. Supervisor Joya's office is helping, and there will be free hot dogs, a DJ and shuttle.

### East Bay Autism Campaign

Working on PowerPoint training module on screening/intervention from a medical perspective to provide information to physicians.
