<u>Special Presentation: It is Flu Season-Be informed about Seasonal and H1N1</u> - Lisa Kleinbub, Director of Health and Behavioral Services, RCEB

H₁N₁

- ❖ The first case recognized in the U.S. was in April 2009. At first it was thought to be similar to a virus in swine, but after more research it was determined to be very similar to seasonal flu and its symptoms: sore throat, body ache, fever over 100.
- The virus is spread via respiratory droplets (which last 2-8 hours) and persons are contagious from 1 day prior to 7 days after symptoms are evident.
- Population most at risk:
 - ➤ Under age 60 with chronic illness
 - > Pregnant women

Methods of Prevention

1. Vaccination

❖ H1N1 vaccine is in limited supply – contact physician to see if you should get one. Priority being given to pregnant women, 25-64 with chronic illness, children under 6 months.



- Seasonal flu vaccine in full supply recommended for those 6 months to 19 years, over 50, and/or with chronic illness.
- ❖ Both vaccinations are available in live or inactive formulas.
- 2. Everyday Actions Critical
- Regular hand-washing (recommend every 2 hours)
- ❖ Avoid sharing equipment (keyboards, telephones, etc.)
- Clean surfaces that people share
- ❖ Avoid contact with sick persons as much as possible
- Sneeze and cough into elbow or tissue
- ❖ Stay home if you are sick and encourage others who are sick to stay home
- Prepare foods and medications at home

CC Public Health is providing FREE seasonal flu shots every Saturday in November at locations throughout the county for priority groups. See website for information or call.

Budget Update/RCEB Update – Jim Burton

- There have been no significant issues or changes since last report.
- It appears that there will NOT be a special budget session called to discuss topics that affect those we serve.
- The Governor's budget is due in January, and state revenues are still down there was a \$1 billion shortfall in July/Aug/September. Estimates keep growing.
- There have been a number of lawsuits files against some of the recent proposed changes:
 - > Transportation
 - > IHSS
 - ➤ Adult Day Health Services
 - > Optional benefits; dental, audiology, etc.
- RCEB has almost completed the changes that reflect the recent trailer bill language. These changes affect many, many families who have been wonderful to work with.
- There are about 100 cases currently in appeal; most of them are in the areas of respite care and social recreation programs.
- We are still a long way from knowing whether the recent cuts will achieve the desired budget reductions.
- Early Start changes have been made and the Prevention Program is in place. About 250 toddlers lost their EIP
 eligibility and have been moved to the new Prevention Program. First 5 of Alameda County is helping, but
 generic services still need to be improved.
- Individual Choice Option there has been much discussion, but no real explanation has been given on how this model will work.

Area Board 5 Appointment

Pam Perls requested that she be re-appointed to a second term. Curtis Braxton made the motion, and Penny Musante provided the second. Pam's re-appointment was unanimously approved.
