**Welcome and Introductions-Stephanie Chapralis:**

The meeting was called to order at 10:05 a.m. and introductions of Speakers were made.

**Topic Presentation: Chad Carlock and Barbara Maizie.**

This presentation explored some of the unique features of the Lantermana Act, explained essential IPP/IFSP rights, and show how they were intended to create a system driven by the needs of each individual. Additionally, the presentation explained why families need to work together to rebuild something that parents, over 40 years ago, created as the best legislation ever enacted for people with developmental disabilities.

The promise the state has made to individuals with developmental disabilities and thier families is more important than ever. In recent years, legislation, funding shortfalls and bureaucratic polices have chipped away at the Lanterman Act. Families need to understand what is happening before we real a "tipping Point" \_ a point when all the power to make decision through the IPP/IFSP process is in the hands of the state.
