

- (3) Data on gas pipeline mileage is from the California Public Utilities Commission (July 2015).
- (4) Data on HL pipeline mileage in Contra Costa County from OSFM staff and does not include empty or abandoned lines.

^{*} There are over 4,000 miles of natural gas pipelines in Contra Costa County, 260 miles of which are transmission lines, and the rest are distribution lines and services. (3) All the natural gas distribution pipelines are operated by Pacific Gas & Electric under the jurisdiction of the California Public Utility Commission. Hazardous liquid (HL) transmission pipelines in Contra Costa County total close to 500 miles. (4) Roughly two-thirds of the HL pipelines carry refined products, and about one-third carry crude oil.

The School Pipeline Safety Partnership

The School Pipeline Safety Partnership ► is a joint program sponsored by the Pipeline Association for Public Awareness and the Danielle Dawn Smalley Foundation. The Partnership's pipeline education program provides information and guidance to school administrators, safety offices and other staff, at schools located near pipelines. Safety information on their site includes information on



leak recognition and response, finding pipelines near schools, protecting pipelines near schools, bus driver safety, activities for teachers (including links to the 811 Kids Program), and Safety Plan Checklists.

Plan of Action for Pipeline Safety Information Center Project Summary

Review of Chester County's existing website and features

- Chester County Planning Department "Pipeline Information Center"

- The interactive Pipeline map is a prime tool that provides address, pipelines at the address, operator name, contact information, product transported and other operators in the area

Chester County's development of the Pipeline Safety Information Center website project included:

- Process started with a PHMSA Technical Assistance Grant facilitated by the Pipeline Safety Coalition (a non-profit public safety advocacy organization)
- Included collaborations with Chester County officials and surveys of local communities to develop the final scope and design.

Plan of Action Summary for Pipeline Safety Information Center Project

Offer to help:

- Both Dr. Simona Perry and Lynda Farrell, the current and immediate past executive directors of Pipeline Safety Coalition have offered their help and guidance for the project.
- Chester County's Planning Department is available to review and discuss the development process in detail with our interested parties via zoom meeting(s).
- PHMSA supplied significant assistance to Chester County in development of the interactive pipeline map feature and, I would anticipate them doing so for our project.

Support:

• This is a formal request of our Hazardous Materials Commission for a letter of support for the project, which builds on our past cooperative efforts for development of the 2015 and 2018 Pipeline Safety Trust's reports to CCCounty, cosponsorship of two series of public Pipeline Safety Workshops (2015 & 2018), CCTV Documentaries and our shared goals for better communication of pipeline safety issues.

Plan of Action Summary for Pipeline Safety Information Center Project

Additional:

- PHMSA's TAG application process ends March 2021
- The need to develop Environmental Justice solutions for the siting of pipeline facilities and the environmental and public health risks faced by certain communities helped create support for the Pipeline Safety Information Center by Chester County as a platform for better communication to all County residents focused on both pro-active local planning and emergency planning and response.
- As a result of the cooperative development between Chester County, the Pipeline Safety Coalition and PHMSA, Chester County offered to maintain the website, which is the goal for this project, to have CCCounty offer to maintain the website.
