1) Call to order, announcements: Commissioner Stewart called the meeting to order at 10:05 am.

- a) Update on the Pharmaceutical Disposal Ordinance

Public Health Director Dan Peddycord is meeting with City Managers this week to discuss their participation in the ordinance. The County is still waiting to hear back from drug wholesalers as to which manufacture's products they sell in the County.

The committee reviewed the flyer for the June 13 cybersecurity workshop and had no changes to recommend.

## 5) New Business

## a) Review Current School Siting Regulation Requirements for Hazardous Chemical Risks

The committee reviewed the state regulations and guidelines for school siting, a comment letter from the Safe Routes to Schools National Partnership and a summary of the areas of concern raised about the state's pipeline risk analysis protocols.

After the review the committee brainstormed approaches they could take to get a better understanding of the potential issues. They came up with the following strategies:

- 1) Look at the EPA's guidelines for school siting
- 2) Look at the Environmental Justice study concept mentioned in the Safe Routes to School letter
- 3) Look at a recent example of a risk assessment done for a local school
- 4) Have a presentation from a speaker that conducts school risk assessments

Commissioner Stewart thought that the best approach would be to prioritize looking at a case study and having a speaker, but that the committee could also look at the EPA guidelines and the EJ study concept. The committee agreed.

Commissioner Stewart also said she would talk to a contact she has a the West Contra Costa Unified School District to see if she could help the committee find a good case study.
