2) Approval of Minutes:

4) Old Business

a) Update on the Pharmaceutical Disposal Ordinance

The Health Department has begun to post at various web sites the community survey discussed at the last meeting designed to collect data about community attitudes and needs concerning unused pharmaceutical disposal options. The survey will be sent to commissioners and they will

be encouraged to fill it out and to post it to appropriate web sites. It will probably remain active until the end of September.

Staff recently learned that Walgreen pharmacies in Walnut Creek and San Pablo now have collection boxes for pharmaceuticals, including controlled medications. These are being run by and paid for by Walgreens, and are the only two in the county that are taking advantage of the new DEA regulations that make this legal.

5) New Business

a) Commission Retreat Planning with Facilitator

Mary Ann Morgan, who will be facilitating the October 27th Commission retreat, joined the meeting to discuss the retreat agenda. The committee reviewed the agenda from the last retreat along with the notes from the retreat that talked about the pluses and minuses of that retreat.

Based on input from the committee, it was decided that a survey would be created for Commissioner to take before the retreat in which they could propose issues they would like to see the Commission address in the next three years. It was also decided to have more commissioner participation in the sharing of background information, so it was decided that the following Commissioners would be asked to prepare to be part of the agenda:

Commissioner Smith – Introduction and Public Comment, and summary of ISO work

Commissioner Stewart - Summary of areas of limited or no activity

Commissioner Sattler - Summary of pharmaceutical work

Commissioner Glueck – Summary of pipeline work

Commissioner Gordon – Summary of brownfield/Northern Waterfront Economic Development Work

The rest of the agenda would remain similar to what was done at the last retreat.

Staff reported that he is still securing a speaker on the topic of brownfield revitalization, and is talking to representatives of the EPA, DTSC and the Center for Creative Land Recycling.
