Legislation Related to Pipelines

Recommendation

Receive report on legislation related to pipelines.

Financial Impact

There is no impact to the County General Fund. Management of the Iron Horse Corridor is funded by the Iron Horse Corridor Trust Fund.

Background

New Legislation:

At the August TWIC meeting, the committee requested staff to review new legislation related to pipelines and if applicable, provide comments based on what is in the best interest of the County and its residents. The enclosed attachment provides information on new bills related to pipelines. All of the bills in this document are for public utilities. Because the Kinder Morgan pipeline in the Iron Horse Corridor (IHC) carries hazardous liquid that is regulated by the State Fire Marshal, the new bills would not apply to Kinder Morgan. The State Fire Marshal's (SFM) Office staff did indicate that although it's possible some requirements from the attached bills may have a future impact on liquid hazardous pipelines, none do at this time. For example, one of the bills includes a requirement for installation of shut-off or remote controlled valves on certain transmission lines. If this requirement was imposed on liquid hazardous pipelines it would affect the one automatic shut off valve for the Kinder Morgan line in the IHC. Staff will continue to monitor the bills and new requirements on liquid hazardous pipelines.

Pipeline Inspection and Repair Reports:

At the June TWIC meeting a concern was raised about the Public Works Department not receiving copies of pipeline inspection and repair reports and pipeline test results from Kinder Morgan when they perform work in the IHC and this information not being available to the public. The SFM Office stated at the time that they were reviewing their public records access policy with their legal department. Public Works staff recently spoke with SFM staff and they have decided on the following process for records requests: The public can make a public records access request by providing in writing the specific information on what they are looking for. The following website http://www.fire.ca.gov/ contains Guidelines to Access Public Records. If the State Fire Marshall's Office was on-site when Kinder Morgan made an inspection and/or repair of a pipeline, they will provide the report to the public requesting it. If they were not on-site during the work, a report would not be available. The attached bills do not address the availability of inspection and repair reports.

Kinder Morgan Easement in the IHC:

Kinder Morgan has an easement with the County for their pipeline in the IHC. This easement was originally between Southern Pacific Transportation Company and Kinder Morgan. The easement was transferred to the County when the property was acquired from Southern Pacific Transportation Company. Staff has been asked about the process to amend the County's easement with Kinder Morgan to include new requirements such as providing copies of inspection and repair reports. The County can initiate dialog with Kinder Morgan regarding the possibility of amending the easement, although this would be a time consuming and expensive process that may not result in a new agreement.

Consequences of Negative Action

The committee will not receive information on pipeline related bills.

Requires the corporation to maintain a specified account for specified expense recovery. Requires corporations and local fire officials to meet regarding the installation of safety equipment. Requires the preparation of a pressure testing plan.
