#### Committee Vice Chair Leng called the meeting to order at 4:08 p.m.

# Introduction of Members and Guests Approval of Minutes from June 14, 2023 meeting Member Tobias motioned to approve the minutes from June 14, 2023. Member Santos seconded the motion. Vice Chair Leng called for a roll call vote for approval of the motion. The roll call vote was done by EMCC Staff Support person Rachel Morris. Voting members Aguiar, Bowles, Drago, Fajardo, Giusti, Gomez, Goudarzi, Greenwood, Kestler, King, Leng, Manier, Maples, Santos, and Wannamaker voted aye; member Tobias voted no; voting members Blanco, Lambert, McMurray, and Schlemmer were absent; motion passed. June 2023 minutes are approved. Comments from the Public No Comments

- 4. Chair's Report
  - Vice Chair Leng reported that there are extra variants of COVID around and new COVID vaccinations should be out later this week. Encouraged all to plan accordingly and stay safe.
- 5. Members' Reports
  - For the Executive Committee election for the 2023-2025 term, Member Wannamaker presented the nominated ballot as follows: Chair James Lambert; Vice Chair Lance Maples and Manuel Gomez; Non-Officer (2) Lance Maples, Nick Fajardo, Joseph Drago, and Manuel Gomez. For the Vice Chair position, Members Gomez and Maples were each given the opportunity to state what interests them in being the Vice Chair. Member Gomez withdrew his nomination for Vice Chair, but would still like to be considered for a non-officer position. Member Maples stated why he is interested in the Vice Chair position and is the sole candidate for Vice Chair. Vice Chair Leng asked members Fajardo, Drago and Gomez to state why they are interested

in being non-officers. Each gave a response. The Committee discussed how to conduct the vote to capture the Chair, Vice Chair, and two non-officer positions. Member King motioned to conduct the vote via paper ballot. Member Tobias seconded the motion. Vice Chair Leng called for a roll call vote for approval of the motion. The roll call vote was done by Vice Chair Leng. Voting members Aguiar, Bowles, Drago, Fajardo, Giusti, Gomez, Goudarzi, Greenwood, Kestler, King, Leng, Manier, Maples, Santos, Tobias, and Wannamaker voted aye; no members voted no; voting members Blanco, Lambert, McMurray, and Schlemmer were absent; motion passed. All eligible voting in-person members completed the vote by paper ballot; all eligible voting Zoom members completed the vote by Zoom chat. The results were counted and the following slate was announced: Chair – James Lambert; Vice Chair – Lance Maples; Non-Officer (2) – Joseph Drago and Nick Fajardo.

- 6. Fire Chiefs' Report Chief Scott Wannamaker, Contra Costa County Fire Protection District (CCCFPD)
  - With the addition of BLS tiered response there will be a chance that FF/medics will be primary medic transferring care to ED staff. They will have the ability to print PCR's at ED.
  - Communications center is being remodeled over the next year and one modification is going to be Auto Verbal dispatching to reduce overall time to dispatch.
  - Preparing MCI drills. One is scheduled at CCCRMC Nov. 15th.
  - Created the Quality Steering Committee and all stakeholders will be invited to participate.
  - Con Fire and AMR paramedic school students are doing well going into their second month of training.
  - Chief Officer series being offered starting in October at SRVFPD, CCCFPD and Oakland by Sterling Fire Training.
  - Flu season and vaccinations are just around the corner.

8. Staff Report: Required Training Update – Rachel Morris, Contra Costa County EMS Agency

EMCC members are now required to complete mandatory Implicit Bias training, in addition to Brown Act training and Ethics training. The County Board of Supervisors added the new bias training on July 11, 2023. Staff Morris presented a slide showing members where they can find the training resources on the County website. New members have three months from appointment to complete the training; existing members have three months from the adoption of the requirement. Once the training has been completed, members are required to submit the executed Updated Training Certification Form, as well as a screen shot of the training completion page. Documents should be emailed to Staff Morris.

- 9. Staff Report: Agency Staffing EMS Specialist Aaron Doyle, Contra Costa County EMS Agency
  The new Ambulance Ordinance that went into effect June 2022 brought new responsibilities. The Agency hired Anna Cleese as an EMS Specialist contract employee through Heluna Health. She has been with the Agency since January 2023 starting as a part time employee and has transitioned to full time. Responsibilities are assisting with ambulance inspections and ambulance compliance. It is more than a full-time job for one person, so the Agency has a new part time contract position for a second EMS Specialist. Once a new person is hired, Anna will transition to assisting with other provisions of the Ordinance, such as special event medical stand by provision.
- 10. Quarterly Update on Alliance Ambulance Services Chief Scott Wannamaker, Contra Costa County Fire Protection District (CCCFPD)
  - BLS tiered response to start Sept. 19th. Anticipating 20-45 BLS calls per day. Asking to receive any feedback during pilot of new model.
  - Recognized Sutter Delta for the steps they've taken to reduce APOT including adding a Pre-Hospital Care RN to monitor patients on the wall.
  - Recently a patient was transported and upon arrival a snake was discovered in her purse.
- 11. EMS Medical Director's Report Senai Kidane, MD, Contra Costa EMS Agency Medical Director
  - The Agency is in the final stages of editing the Annual Training. The training will be in video format, available online.
  - The Agency is endeavoring to expand the Buprenorphine LOSOP. Parts of the County are not currently participating, so for equity of the System, the goal is to expand to all transporting providers. Conversations are being had with San Ramon Valley Fire Protection District, and Moraga-Orinda Fire District to bring the LOSOP to their districts.
  - Member Bennett, who is out on paternity leave, asked Member Kidane to mention that late last month the Agency published Policy 3003, Dispatch Requirements for 911 Resources, effective September 19, 2023. The policy supports the data driven 911 tiered response. As a reminder, BLS transports for medical requests for currently are confined to Central and East County. The Agency is working with provider agencies and the Alliance to ensure BLS expansion is supported by a robust quality assurance plan to ensure the safety of the program. The policy also includes a provision for the use of Card 38, also known as the SEND Protocol with law enforcement, which hopes to address appropriate triage of requests for 911 medical resources for law enforcement, which currently can be seen as a gap in our System.

Meeting Attendance Requirements per the Bylaws:

- A. EMCC members shall attend EMCC meetings.
  B. A member who cannot attend a meeting must notify the Chair and may have one excused absence in a twelve month period.
  C. Whenever a member does not attend two regularly scheduled meetings, within a rolling twelve month period, complete their Brown Act requirements or fails to meet the criteria for sitting on the advisory body the EMS Agency shall notify the nominating agency/organization of the absences and request appropriate action.

  D. Members must complete the required Ethics and Brown Act training provided by the County
- D. Members must complete the required Emics and a rown Act training provided by the County within three months of appointment and submit the 'Training Certification for Member of County Advisory Body' form to EMS staff prior to participating at any meeting.

  E. Members who do not complete the Ethics and Brown Act training within 3 months may not further participate until the requirement is fulfilled.

  F. Ethics and Brown Act training is recommended to be completed every two years while serving
- on a County Advisory Committee.

#### **Annual Report for 2023**

#### I. Activities:

The EMCC, over four (4) regular meetings in the past year, was involved in or kept its membership informed about the following:

- Continued discussion on the update to the county ambulance ordinance. The new ambulance ordinance was
  adopted by the Board of Supervisors; the Contra Costa County EMS Agency (CCCEMSA) continues to create internal
  systems to support the new ordinance deliverables (i.e., fee schedules, special event standby, DOJ background
  access).
- The Board of Supervisors recognized May 21-27<sup>th</sup> as National EMS Week, and May 24<sup>th</sup> as EMS for Children Day.
- Treatment guidelines and policies updated for 2024 are finalized. Implementation is January 1<sup>st</sup>, 2024.
- Continued discussion on adverse impacts on 9-1-1 ambulance providers and patient care associated with prolonged ambulance patient offload delays (APOT).
- CCCEMSA continues the III phase process via consultant (FITCH) to perform an EMS System evaluation that will inform the next RFP for emergency ambulance services in ERAs I, II, and V.
- CCCEMSA is endeavoring to expand the Buprenorphine LOSOP. Parts of the County are not currently participating, so for equity of the System, the goal is to expand to all transporting providers. Conversations are ongoing with San Ramon Valley Fire Protection District, and Moraga-Orinda Fire District to bring the LOSOP to their districts.

#### II. Accomplishments

- Approval of EMCC 2022 Annual Report.
- Successful nominations and establishing a new EMCC Executive Committee for the 2023-2025 term.
- Based on a 6-year CCCEMSA study of 911 ambulance transports and critical ALS interventions administered for each MPDS sub-determinant, BLS Tiered response was launched in East and Central County September 19<sup>th</sup>, 2023.
  - o Provider has reported better than expected system impact and no sentinel events have occurred.
- Published updated Public Safety First Aid policy to support Law Enforcement AED and Narcan programs and to support volunteer agency personnel who are integrated into EMS system.
- Creation and implementation of contract position "EMS Specialist". The position is focused on performing ambulance inspections and supporting CCCEMSA internal Ambulance Ordinance processes and compliance.
- Received the American Heart Association's Mission: Lifeline® regional STEMI achievement award for its commitment to rapid, research-based care to people across the region experiencing the most severe form of heart attack.

#### III. Attendance/Representation

The EMCC is a multidisciplinary committee with membership consisting of representation of specific EMS stakeholder groups and organizations plus one (1) consumer member nominated by each Board of Supervisor member. There are twenty-four (24) authorized, voting seats, and two (2) non-voting, ex-officio seats on the advisory body. In 2023, twenty (20) voting member seats and two (2) ex-officio seats were filled; four (4) seats were unfilled. A quorum was achieved at four (4) of the four (4) regular EMCC meetings in 2023.

#### IV. Training/Certification

Each new EMCC representative was given a copy of the Advisory Body Handbook and copies of the "The Brown Act and Better Government Ordinance Training Video" and "Ethics for Local Government Officials" video offered by the Fair Political Practices Commission during their two (2) year term. Beginning July 14, 2023, Implicit Bias training was added to the required training for EMCC members. New members are given three (3) months from appointment to complete the Implicit Bias training, and current members were given three (3) months from the July 14 adoption of the new training requirement. Responsibilities of County Boards were discussed including the responsibility to view the videos and submit

signed certifications. In 2023, completed certification forms have been received from fourteen (14) of twenty-two (22) representatives so far. The fourteen (14) certificates received this year are attached to this report.

#### V. Focused Objectives for Next Year

- Continue to refine EMS Emergency Quality Improvement Plan (EQIP) and support stakeholder processes related to Quality Assurance and Quality Improvement:
  - Stakeholder Education
  - Stakeholder support in building relevant, achievable, and sustainable Quality Improvement Plans that align with the CCCEMSA EQIP, CA Regulation and State 'core measure' deliverables.
- Support opportunities for more efficient response and transport model to include:
  - Tiered response monitoring and refinement
  - Supporting behavioral health models that shunt non-medical calls away from EMS system or lessen the current burden on the EMS system.
  - Improve triage of EMS calls for service generated by law enforcement.
  - Shunting non-emergent 911 calls to RN advice line.
- Support emergency ambulance provider and community hospitals efforts to reduce patient transfer of care extended delays that impact the availability of ambulances for the next 9-1-1 call.
- Resolve outstanding 2017/2018 EMS Plan appeal with EMSA; submit subsequent EMS Plans to bring Contra Costa current.

#### VI. Expected 2024 Reports, Updates, and Continued Support Items

- Continue to support stakeholder opportunities and efforts to procure sustainable funding for EMS System emergency
  communications, dispatch, and data infrastructure enhancements to optimize patient care in day-to-day and disaster
  conditions.
- Support Public Health Medical Health Disaster Coalition preparedness and engagement as it pertains to the EMS System. Continue to monitor and report on EMS System impacts due to changing economics and health care reform.
- Support EMS System program (STEMI, Stroke, Cardiac Arrest, EMSC, Quality/Patient Safety and Trauma) initiatives.
- Support and sustain community education and outreach.
- Support appropriate use of 9-1-1, CPR Anytime, and Automatic External Defibrillator (AED) programs through partnerships with Law Enforcement, CERT, fire first responders, and community coalitions.
- Receive updates on treatment guidelines and policies for 2024.
