#### 1. Clinics

- a. Now have standing Monday PM clinic @ GRIP
  - i. Used to be 2x a week on Fridays with outreach.
  - ii. Now we have a big bus there weekly.
  - iii. Open to community members
- b. BARM and GRIP on Mondays
- c. Now full day clinic on Antioch
  - i. Tuesdays @Community Cares Center / Dairy Queen
  - ii. Used to be outreach clinic half day
  - iii. Next to executive inn new Antioch shelter.
- d. Fulton Clinic
  - i. Longstanding clinic
  - ii. It is not flat to park the big bus.
  - iii. Have reached out to Terri and Jazmin about new spaces.
  - iv. Challenges for wheelchair lift and bus
  - v. Need a new Thursday afternoon for Antioch.
  - vi. Requirements for ingress/egress
    - \*Fairgrounds JR Wilson
    - \*MCO sup can come out and look at it

# Standing Item: Quality Improvement

(Gabriella Quintana, HCH QI Team)

- 1. Site Visit
  - a. HRSA site visit next year.
  - b. Preparation in the coming months.
- 2. Consumer Advisory Board
  - a. First meeting Aug 30th
  - Based on recommendations received by the National HCH CAB, an initial consumer work group will develop the CAB with only the guidance and support of HCH Staff.
  - c. 4 patients attended the workgroup meeting and began identifying logistical components of the CAB important for this development including meeting frequency, location, food, and gift cards.
  - d. As part of their introduction, everyone shared how HCH has helped (or not helped) them.
  - e. The most common themes around help received were related to mental health, either through group therapy or our staff helping connect them to therapy. Their identified areas where HCH could improve included increasing awareness of resources, outreach and advocacy, more support for those with needs between respite and being fully independent, and improved medication delivery systems for those in encampments.
