## *Network Provider CPT Code Tip Sheet*

---

- **Assessment** (90791/90792) services **may not** be billed on the same day as individual therapy, family therapy with the client, and/or group therapy. All services are captured under the CPT code with the most time. For example, if 30 minutes is spent finishing an assessment and 45 on individual therapy, all services will be billed under the individual therapy CPT code. For this example, the provider will bill 1 unit of 90837 and 2 units of G2212. Within the body of the progress note, the description will capture the different services.
  
- **Assessment** (90791/90792) **may** be billed on the same day as crisis (90839, 90840) or psychiatric E & M codes (99202-99205 or 99212-99215). When billing these combinations, use the 59 modifier with the assessment code.
  1. If also using **G2212** as an add-on code for both CPT codes, **bill all units on one service line**.
  
- **More than 1 CPT code provided in one day:** When billing eligible CPT code combinations within one day, only one code is eligible to have the 59 modifier.

Common scenarios:

1. Billing **individual** (90832, 90834, or 90837) and **family therapy** (90847) on the same day.
    - a. Modifier 59 will be used for the individual therapy CPT code.
    - b. If billing family therapy without the client (H0032) **no modifier** is needed.
  
  2. Billing **individual** (90832, 90834, or 90837) and **group therapy** (90853) on the same day.
    - a. Modifier 59 will be used for the individual therapy CPT code.
  
  3. Billing **assessment** (90791/90792) and a psychiatric **E & M code or crisis code** on the same day.
    - a. Modifier 59 will be used for the E & M or crisis code.
- **Crisis codes** (90839/90840)
    1. These codes may only be billed when services are provided **in person** (Place of Service type 11).
  
    2. If the service is provided via **Telehealth** (Place of Service type 02 or 10) use **H2011**.
      - If H2011 was provided via phone, use the SC modifier. Video services do not require a modifier.
  
    3. Individual therapy, family therapy with the client, & group therapy may not be billed on the same day as a crisis code. Instead, bill all billable time using the crisis code(s).

## *Network Provider CPT Code Tip Sheet*

- **G2212**

1. This is an “add-on” code. It may only be billed when the primary code is:
  - 90791,
  - 90792,
  - 90837,
  - 90847,
  - 90853,
  - 90885,
  - 96110,
  - 96127,
  - 99205, and
  - 99215
2. The only eligible modifier is SC (phone service).

- **H0032/H2021**

1. These codes do not require a 59 modifier if billed on the same day as another CPT code.
2. Will only use a modifier if this service was provided via phone (use modifier SC).

- **T1013**

1. This code is used when Sign Language or Oral Interpretive Services were utilized during a session.
2. T1013 may not be used with 90785 (Interactive Complexity).
3. T1013 must be billed with a primary service code. For example:
  - a. If a 50-minute family session with the client was provided, 1 unit of 90847 and 3 units of T1013 will be billed.
4. The only modifier used with this code is SC (Telehealth via phone).
