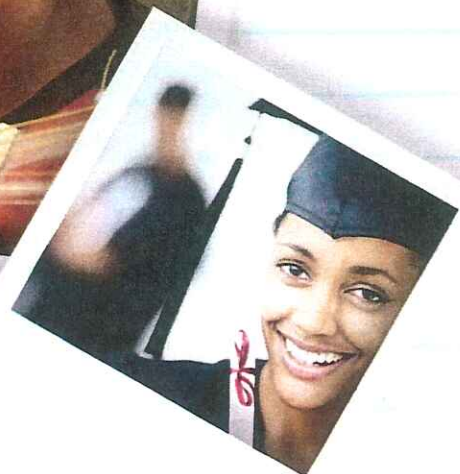
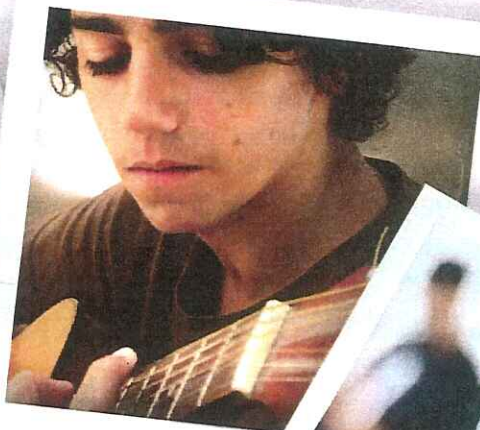
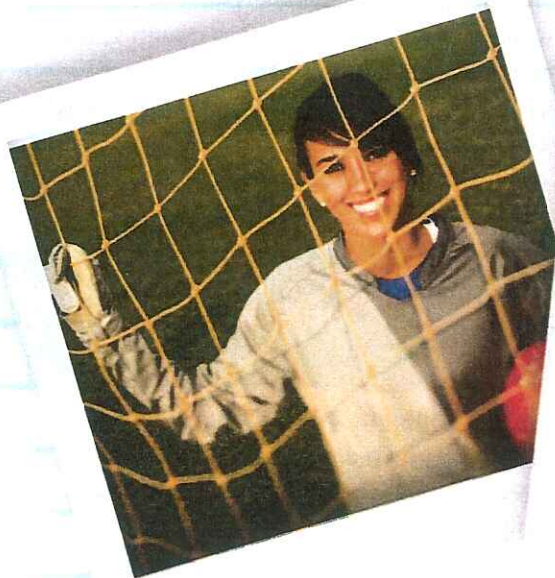

What Shots Does My Child Need?

As parents, we can't be near our children every minute. Immunizing our children is one thing we can do to protect their health for years to come.

REQUIRED vaccine for 7th – 12th graders 2011-2012 school year	What this means for YOUR child
Tdap (tetanus, diphtheria, pertussis)	Tdap safely protects against 3 dangerous diseases: tetanus, diphtheria, and whooping cough (also called pertussis). Whooping cough has been increasing in the U.S. It continues to be widespread in California. For the 2011–12 school year only, children entering 7th–12th grade will need proof of a Tdap shot before starting school. For 2012-13 and beyond, only students entering 7th grade will need proof of a Tdap shot.

RECOMMENDED vaccines for 7th – 12th graders	What this means for YOUR child
Meningococcal	Meningococcal meningitis is easily spread by kissing, sharing drinks, coughing, or sneezing. This disease could cause your otherwise healthy child to lose an arm or leg, become paralyzed, or die. The shot can protect them from several types of this deadly infection.
Chickenpox (Varicella)	Chickenpox is usually worse for adolescents and adults than for kids. A total of two doses of chickenpox vaccine are needed if your child has never had chickenpox disease.
Human Papillomavirus (HPV)	This 3-shot vaccine series is recommended for girls to help protect them from cancer of the cervix (a part of their reproductive system) later in life. Boys ages 9 to 26 years may also receive the vaccine.
Seasonal Flu	The flu is a serious illness. Even young and healthy children need protection against the flu! This year's flu vaccine protects against 3 flu viruses, including the H1N1 flu virus.

Children should visit their doctor or health care provider to get their shots. Children 18 years old and younger who are uninsured or underinsured may qualify for the Vaccines for Children Program to get free or low cost immunization services. EARLY ALERT TO HEALTH CARE PROVIDERS
Assembly Bill 354 Becomes Law
2011 Pertussis (Whooping Cough) Immunization Requirements for Students
September 30, 2010 (Updated December 9, 2010)

Whooping cough (pertussis) has been widespread, including nine infant deaths, in California during 2010. The California Department of Public Health (CDPH) recommends that all Californians 10 years and older receive a booster shot against pertussis (also known as "Tdap"¹). Moreover, Assembly Bill 354, now chaptered into California law, requires students to be immunized against pertussis²:

For the 2011-12 school year only, all students entering 7th through 12th grades will need proof of a Tdap booster shot before starting school. This requirement:

- Begins July 1, 2011.
- Will be met by the CDPH recommendation to receive one dose of Tdap vaccine on or after the 10th birthday.³
- Applies to all public and private schools.
- Does not affect students enrolled in summer school.

Beginning July 1, 2012, and beyond, all students entering the 7th grade will need proof of a Tdap booster shot before starting school.

These requirements apply to millions of students in California. Please utilize every opportunity to provide a Tdap booster shot to adolescents and adults (10 years and older) who haven't yet received it. Give Tdap now to your unimmunized patients to protect them against the current threat and to meet the forthcoming school requirement. Schools may send communications about the Tdap requirement to the parents of your patients.

The California Immunization Registry (CAIR) is directly accessed by many schools to check student immunization records. We encourage you to join CAIR to help meet the new Tdap booster shot requirement ([click here](#) for CAIR contact information).

Updates on implementing this new law and information on pertussis will be posted later in the 2010-2011 school year at www.getimmunizedca.org.

¹ "Tdap" = Tetanus toxoid, reduced diphtheria toxoid and acellular pertussis vaccine.

² Exemptions permitted for verified medical conditions or personal beliefs.

³ If a student has received a dose of Tdap on or after the 7th birthday, the student will meet the school immunization requirement

Consent for minors:

- Children under 14 years of age must be accompanied by a parent, legal guardian or authorized relative or caretaker.
- Unaccompanied children 14-17 years must have an informed consent signed by the parent, legal guardian or authorized relative or caretaker. The parent, guardian, or authorized relative or caretaker needs to indicate their relationship to the child and give a phone number where they can be reached.



California law requires, that at the time of enrollment in California schools, children must have or must obtain the following immunizations (with some exceptions based on age, religious belief, or medical reasons):

IMMUNIZATIONS REQUIRED FOR SCHOOL ENTRY, K-12		
POLIO	4 doses	But... 3 doses meet requirement if at least one dose was given on or after the 4 th birthday.
DIPHThERIA, TETANUS, AND PERTUSSIS Age 6 years and under (Pertussis is required) DTaP or DTP, or any combination of DTaP/DTP with DT or Td (Tetanus and Diphtheria)	5 doses but...	4 doses meet requirements for ages 4-6 if at least one dose was given on or after the 4 th birthday.
Age 7 years and older (Pertussis is <u>not</u> required) Td, DT, DTaP, DTP, Tdap or any combination of these	4 doses but...	3 doses meet requirement for ages 7-17 years if at least one dose was given on or after the 2 nd birthday. If last dose was given before the 2 nd birthday, one more (Td or Tdap) dose is required.
MEASLES, MUMPS, RUBELLA (MMR) Given together as one injection	1 or 2 doses (2)	Must be given on or after the 1st birthday.
HEPATITIS B	3 doses	Required for all children entering kindergarten on or after 8/97, and all children entering 7 th grade on or after 7/1/99.
VARICELLA	1 dose	Required for all children entering kindergarten, 18 months of age and older or as an alternative, provider documentation of chickenpox disease.

- Mumps is recommended but not required for children over age 7.
- A second dose of MMR is legally required at kindergarten entry and 7th grade entry.

15-17 months.....	3 Polio, 3 DTaP (or DTP) and 2 Hep B 1 Hib at any age 1 MMR is needed on or after the 1st birthday
18 months through 4 years.....	3 Polio, 4 DTaP (or DTP), 3 Hep B, 1 Hib 1 MMR given on or after the 1st birthday 1 Varicella required for all children 18 months of age and older or provider documentation of chickenpox disease



DOCUMENTATION: All pupils entering schools, day care, preschool, headstarts or family day care homes must present a written immunization record from a health care provider. Transfer students may present the California School Immunization Record (the blue card) from their prior school. The record must show the month and year for each vaccine received, and month, day, and year for MMR and Hib if received in the month of the first birthday.

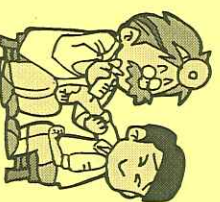

Consentimiento para menores de edad:

- Todos los menores de 14 años de edad deben venir acompañados por uno de los padres, apoderado legal o la persona autorizada por los padres.
 - Niños de 14 a 17 años de edad que no estén acompañados por un adulto, deben de tener un consentimiento firmado por los padres, apoderado legal o persona autorizada por los padres
- La persona que firme el consentimiento debe indicar en el mismo su parentesco con niño y el número de teléfono a donde se les pueda localizar



La ley de California requiere, que cuando los niños se registren en las escuelas de California, tienen que tener, o deben obtener las siguientes vacunas (con algunas excepciones dependiendo de la edad, creencias religiosas o por razones médicas):

VACUNAS REQUERIDAS PARA INGRESAR A LA ESCUELA		
POLIO	4 dosis	3 dosis cumplen con el requisito si por lo menos recibió una dosis después del cuarto cumpleaños.
DIFTERIA - TETANOS - TOS FERINA (DTP) Menores de 6 años (Requieren la vacuna contra la Tos Ferina) DTP/DTaP o cualquier combinación de DTP/DTaP con DT ó Td (Tétanos y Difteria)	5 dosis pero...	Cuatro dosis cumplen con el requisito si la última dosis se administró después de los 4 años de edad.
Mayores de 7 años (No requieren la vacuna contra la Tos Ferina) Td, DT, ó DTP/DTaP, Tdap ó cualquiera combinación de estas.	4 dosis pero...	3 dosis llenan los requisitos para las edades de 7 a 17 años si por lo menos una dosis fue dada el día del segundo cumpleaños o después. HEPATITIS B	3 dosis	Requerida para entra al kinder durante el mes de Agosto de 1997 o después y para todos los niños que entren al 7o. grado el 1 de Julio de 1999 o después.
VARICELA	1 dosis	Requerida para todos los niños que entran a kinder, niños de 18 meses y mayores. Como alternativa se acepta documentación del proveedor médico indicando que el niño tuvo varicela.

- (1) Para niños mayores de 7 años se recomienda la vacuna contra las Paperas, pero no es obligatorio.
- (2) Una segunda dosis de la vacuna MMR (Sarampión, sarampión alemán, paperas) es un requisito legal para ingresar al kinder y para ingresar al 7 grado.

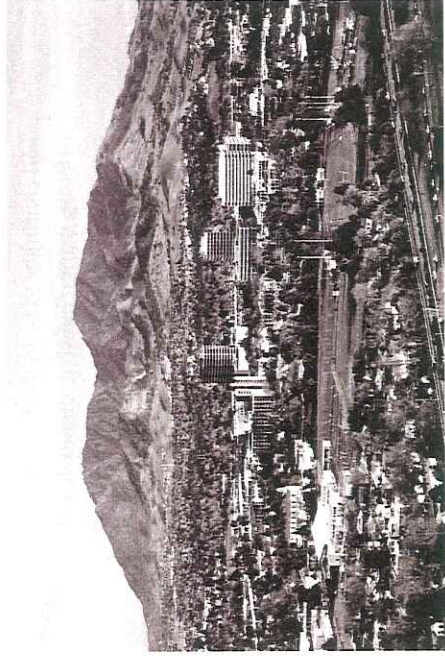

DOCUMENTACION: Todos los estudiantes que entren a una escuela guardería o programa de aprendizaje en California deben presentar una prueba por escrito del doctor o clinica de inmunizaciones, indicando fechas de vacunas recibidas. Los estudiantes que se estén cambiando de escuela pueden presentar la documentación de la escuela anterior. 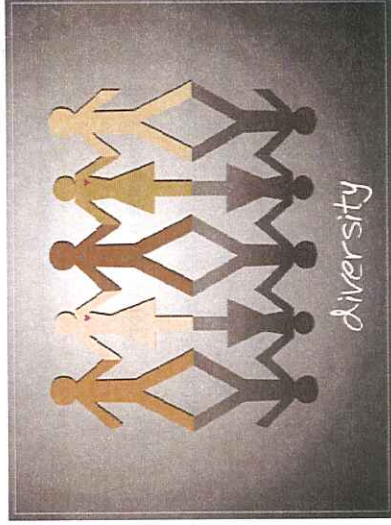

What is Contra Costa Health Plan (CCHP)?

We are a local health plan associated with Contra Costa County Health Services, and have over 36 years of experience in providing health care. Coverage. CCHP is a federally qualified HMO which serves almost 100,000 member lives in Contra Costa County and continues to be in the forefront in offering comprehensive, quality health coverage for people who live and/or work in our community.

Who are CCHP's members?

CCHP serves Medi-Cal and Medicare recipients as well as County employees, individuals, families, employees of business groups and IHSS homecare workers. We are also a carrier under the State's Healthy Families, Access for Infants and Mothers and Major Risk Medical Insurance Programs. Additionally, we coordinate the care of low income, uninsured County residents under the County's Basic Health Care, and Health Care Coverage Initiative programs and the new Medi-Cal Expansion Program.

How do I check member eligibility?

CCHP has a toll free eligibility and PCP assignment verification number available 24/7. Eligibility requests can also be faxed to CCHP for confirmation. PCP's receive a weekly fax listing of members assigned to their panel.

What resources within CCHP will help me manage a member's care?

CCHP has a **24 hour Advice Nurse line** available to all health plan members that can **assist you with off hours coverage at no cost to you or the members.** Our Case Management unit works closely with members and their families, and provider to achieve the highest positive health outcomes for each individual. Also, there are valuable **member support programs** such as **asthma and diabetes management, prenatal follow-up and referrals for mental health services**

What about referrals to specialty providers?

CCHP maintains a comprehensive listing of contracted Specialty Care Providers. PCP's may refer members to a specialist by completing a referral form or by obtaining prior authorization for specialty care.

What about pharmacy coverage?

CCHP contracts with a pharmacy benefits manager (PBM) that subcontracts with local pharmacies to fill prescriptions. Our formularies can be easily found on our website and via Epocrates.

What is the turnaround time for claims?

For most of our programs, provider claims are submitted directly to CCHP. CCHP pays clean Medicare member claims within 30 business days and all other member claims within 45 business days.

What are the advantages of being a CCHP contracted provider?

With the advent of health care reform within the next few years, CCHP is in the forefront of implementing the proposed changes. **Beginning in June, CCHP expects to enroll up to 1,000 per month, new Medi-Cal members, eligible Fee For Service adult Medi-Cal patients, who are Seniors and Persons with Disabilities (SPDs), over a 12 month period.** Many of these are **patients you may currently be seeing and we feel that these special patients deserve every opportunity to continue to be cared for by the Primary Care Providers and Specialists that they know and trust, like you. CCHP is dedicated to meeting the needs of our providers and members by providing timely and personalized service to both.**

How do I become a provider?

All providers, including non-physician medical practitioners, applying to the CCHP network must be credentialed and contracted prior to providing services to members. CCHP follows National Committee for Quality Assurance (NCQA) guidelines and standards for initial credentialing and recredentialing.
